

**AMENDMENT
TO
MEMORANDUM OF UNDERSTANDING
TO ALLOCATE PROPOSITION C 40% DISCRETIONARY FUNDS
FOR THE LOS ANGELES COUNTY REGIONAL ZERO EMISSION TRANSIT
CAPITAL PROGRAM (ZETCP)**

RECITAL:

WHEREAS, the Los Angeles County Metropolitan Transportation Authority (“LACMTA”) and City of Commerce (“GRANTEE”) previously entered into a Memorandum of Understanding on October 1, 2024, (the “Existing MOU”).

WHEREAS, the Existing MOU allocated a total of \$49.84 million in ZETCP – Equivalent funding to be divided amongst Included and Eligible Transit Operators;

WHEREAS, on June 26, 2025, the Board approved the reduction of \$49.84 million to \$18.5 million in ZETCP – Equivalent funding (Proposition C 40% Discretionary) for Included and Eligible Transit Operators as presented in Exhibit A-1, commensurate with ZETCP fund availability to Metro. The board also delegated authority to the Chief Executive Officer to negotiate any future amendments if further adjustments are made to funding availability;

NOW THEREFORE, in consideration of the mutual term and conditions contained herein, LACMTA and GRANTEE hereby agree as follows:

1. Exhibit A of the Existing MOU is hereby amended by deleting it and replacing it with Exhibit A-1, the REVISED ZETCP-EQUIVALENT FUND ALLOCATIONS, attached hereto.
2. ARTICLE 2.1 of the existing MOU is hereby amended by deleting it in its entirety and replacing it with the following:
 - 2.1 Attached as Exhibit A-1 is the board approved REVISED ZETCP-EQUIVALENT FUND ALLOCATIONS. GRANTEE shall receive sixty-one thousand four hundred twenty-two dollars (\$61,422) in FY25 only. GRANTEE agrees that the advanced allocation of funds allows for immediate use. LACMTA shall not be obligated to forward the funds for the ZETCP to GRANTEE until it receives an invoice, and the ZETCP Service Improvement Plan.
3. Except as expressly amended hereby, the existing MOU remains in full force and effect as originally executed. All rights and obligations of the parties under the existing MOU that are not expressly amended by this Amendment remain unchanged.

IN WITNESS WHEREOF, the parties hereto have caused this Memorandum of Understanding to be duly executed as of the dates below with all the formalities required by law.
