

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA, AUTHORIZING THE SUBSTANTIAL AMENDMENT TO THE 46TH AND 47TH YEAR OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR FISCAL YEARS 2020/2021 AND 2021/2022, AND AUTHORIZING THE ALLOCATION FOR THE 48TH YEAR OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR FISCAL YEAR 2022/2023

WHEREAS, the Community Development Block Grant (CDBG) Program has operated since 1974 to provide local governments with resources to meet the needs of persons of low to moderate income; and

WHEREAS, the City of Commerce contracts with the Los Angeles County Development Authority (LACDA) for disbursement of Community Development Block Grant Funds, through the Small Cities Program; and

WHEREAS, the City Council passed Resolution No. 20-7 on January 21, 2020, approving the 2020/2021 CDBG project funding; and

WHEREAS, the City Council passed Resolution No. 21-5 on January 19, 2021, approving the 2021/2022 CDBG project funding; and

WHEREAS, the City of Commerce will substantially amend the 2020/2021 and 2021/2022 CDBG project funding to include the cancellation of the City's 2021/2022 CDBG funded Community Policing Program (D97137-21) and the reallocation of this project's funding of \$10,000.00 and allocation of \$169,001.89 of unallocated prior year funds, for a total of \$179,001.89, to the City's 2020/2021 Home Preservation Grant Program (601074-20). The Home Preservation Grant Program's 2020/2021 funds of \$159,888.00 will be increased by \$179,001.89 bringing the Program's total funding amount to \$338,889.89 for FY 2020/2021; and

WHEREAS, the City of Commerce will receive an estimated total of \$124,034.00 of funds for Fiscal Year 2022/2023 in Community Development Block Grant Funds and will utilize the funds to budget toward projects; and

WHEREAS, the City Council has conducted a public hearing and the required prior noticing to provide the public an opportunity to comment on the Fiscal Years 2020/2021 and 2021/2022 Substantial Amendment and Fiscal Year 2022/2023 proposed programs for the Community Development Block Grant Program.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE DOES HEARBY RESOLVE AND ORDER AS FOLLOWS:

Section 1: The City Council approves the Community Development Block Grant (CDBG) Program Substantial Amendment for Fiscal Years 2020/2021 and 2021/2022 and directs staff to submit the necessary documents and a copy of this Resolution to the

Los Angeles County Development Authority for approval of the 2020/2021 and 2021/2022 CDBG Substantial Amendment as follows:

Section 4: The City Manager or his designee is authorized to execute the contractual and related documents to be prepared by LACDA that are required for the implementation of the programs contained herein.

Section 5: This Resolution shall take full force and effect immediately upon adoption by the City Council.
