**SUBJECT:** A Resolution of the City Council of Commerce, California, Approving Change Order #1 for the Purchase of a New 2025 40' Battery Electric Low-Floor Bus in an Amount not to exceed \$1,803,051, and an increase of \$318,937

# **RECOMMENDATIONS**:

Staff recommends that the City Council adopt a resolution to approve the change order #1 for the purchase of a new 2025 40' Battery Electric Low-Floor Bus for transit fixed route operations for \$1,803,051, an increase of \$318,937, utilizing the State of Washington, RFP#2020, Purchasing Contract No 06719-01.

# BACKGROUND:

On May 24, 2024, the City Council approved the purchase of a New 40' Battery Electric Low-Floor Bus in an amount not to exceed \$1,484,114. The State of Washington's contract documents comply with all the requirements set by the State, Federal Transit Administration, and the City for competitive procurement. The Transportation staff has determined that purchasing this bus is of the utmost importance for providing reliable transit services and complying with California Innovative Clean Transit (ICT) fleet regulations.

# ANALYSIS:

The primary reason for the increase is associated with recent tariffs for manufacturing components required to complete the construction of the battery electric bus. The proposed 40-foot Battery-Electric bus will comply with the California Air Resources Board (CARB) Innovative Clean Transit (ICT) Regulation and the City of Commerce Transportation Rollout Plan. As per the Public Transit Agencies' requirement, zero-emission technology is mandatory for transit fleet equipment, and by 2040, 100% of the transit fleet equipment must be zero-emission. This bus purchase will contribute to the department's electrification milestones.

# **FISCAL IMPACT**

The proposed 40' Battery Electric Low-Floor Bus purchase will cost approximately \$1,803,051 in FY26, utilizing Federal Section 5307 grant funds (Grant # CA-2025-093-00).
