2024 COLLEGE FAIR UPDATES

Librarian Erik Jackiw provided Commissioners with an update on the approaching college fair:

- We have also received confirmation of participation from Whittier College, Cerritos College, East LA College, and Friends of Montebello Unified School District Foundation.

- Student panels will also be presenting, which may include prior Commerce Scholarship recipients.

LIBRARY PATIO RIBBON-CUTTING CEREMONY
