## **RESOLUTION NO.**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA APPROVING A 1<sup>ST</sup> AMENDMENT WITH COMMERCIAL REFUSE HAULERS OPERATING UNDER A SEMI-EXCLUSIVE AGREEMENT NAMELY, AAA RUBBISH, ATHENS SERVICES, HAUL AWAY RUBBISH SERVICE COMPANY, NASA SERVICES, REPUBLIC SERVICES, UNIVERSAL WASTE SYSTEMS, AND WASTE MANAGEMENT COMPANY

**WHEREAS**, on February 28, 2023, staff presented a commercial hauler update report as those haulers operating under a business license only were due to expire in March 2023 per the 5-year notice and the remaining commercial haulers operating under a semi-exclusive agreement were due to expire on October 31, 2023, which includes:

- 1. AAA Rubbish
- 2. Athens Services/Calmet Services
- 3. Haul Away Rubbish Service Company
- 4. NASA Services
- 5. Republic Services
- 6. Universal Waste Systems
- 7. Waste Management Company; and

**WHEREAS**, several options were presented to Council including 1. Extending the term by two years as allowed by the existing agreement, 2. Releasing a Request for Proposals (RFP) and reducing the number of waste haulers under an agreement, and 3. Entering into an exclusive franchise agreement with one hauler following an RFP process; and

WHEREAS, Council directed staff to return with amendments for the commercial haulers operating under a semi-exclusive agreement to extend the term of the existing agreements by two additional years; and

**WHEREAS**, staff recommends that the City Council approve a Resolution and the 1<sup>st</sup> Amendments to extend the term of the commercial hauler agreements as directed by the City Council with a new Semi-exclusive Agreement expiration date of October 31, 2025.

NOW, THEREFORE, THE CITY COUNCIL DOES HEREBY RESOLVE, DECLARE AND DETERMINE AS FOLLOWS:

<u>Section 1</u>. The City Council of the City of Commerce hereby finds and declares that the foregoing recitals are true and correct, and incorporates them herein as findings and as a substantive part of this Resolution.

<u>Section 2.</u> Approve execution of the 1<sup>st</sup> Amendments, in forms approved by the City Attorney, to extend the term of the semi-exclusive agreements with AAA Rubbish, Athens Services, Haul Away Rubbish Service Company, Nasa Services, Republic Services, Universal Waste Systems, and Waste Management Company with a new expiration date of October 31, 2025.

<u>Section 3.</u> The Mayor is hereby authorized to execute this Resolution and amendments for and on behalf of the City of Commerce.

**Section 4.** This Resolution shall take full force and effect immediately upon adoption by the City Council.
