**SUBJECT:** Tree Maintenance Services Award of Agreement

**MEETING DATE:** September 26, 2023

#### **RECOMMENDATION:**

The City Council will consider for adoption a Resolution approving an Award of Agreement to Great Scott Tree Service for tree maintenance services for an initial term of 3 (three) years effective October 2, 2023 with an option to extend for an additional 2 (two) years.

## **BACKGROUND:**

On November 22, 2022, City Council approved the First Amendment to the Agreement with West Coast Arborists (WCA) for tree maintenance services to extend the term until October 1, 2023 and directed staff to release a Request for Proposals (RFP). Staff released the RFP on July 11, 2023 with a proposal submittal deadline of August 10, 2023. The City of Commerce received 5 proposals from Great Scott Tree Service, West Coast Arborists, Mariposa Tree Management, North Star, and Golden West ranging in quality and capability as well as annual costs.

## **ANALYSIS:**

In general, proposals were evaluated for their quality, completeness, corporate capability, customer service program, safety training program, industrial safety record, information management system, pruning program, equipment availability, and fee schedule. Table 1.0 depicts each proposer along with the final evaluation scores and total costs. Table 2.0 below arranges each proposer according to the proposed annual cost.

Great Scott Tree Care ranks first in both of these criteria. Based on the analysis discussed herein, staff recommends awarding an Agreement for Tree Maintenance Services to Great Scott Tree Service Company for an initial term of three (3) years effective October 2, 2023 with an option to extend the term of service by an additional two (2) years.

## **FISCAL IMPACT:**
