- **SUBJECT:** Update Regarding the Recently Approved Encampment Delegated Maintenance Agreement with the State of California Department of Transportation

MEETING DATE: June 24, 2025

#### **RECOMMENDATION:**

Receive an update regarding the recently approved Encampment Delegated Maintenance Agreement (EDMA) between the City of Commerce and the California Department of Transportation (Caltrans)

#### BACKGROUND:

The City of Commerce sought the opportunity to enter into an Encampment Delegated Maintenance Agreement (EDMA) with Caltrans. The EDMA was approved by the City Council at its regularly scheduled meeting on June 10, 2025. This agreement, which has an initial duration of three (3) years, authorized the City to take over maintenance responsibilities at the nine (9) freeway on- and off-ramps listed below, which provide access to and from the City. These responsibilities include the removal of litter and large items, and graffiti and weed abatement.

The agreement aligns with the City's ongoing efforts to address issues associated with

unsheltered encampments and to maintain safety and cleanliness in the State right-ofway. This agreement specifically addresses enhanced services for encampment-related and aesthetic concerns.

### ANALYSIS:

By assuming maintenance duties for the designated ramps, the City is able to proactively address public safety hazards, improve visual conditions at key gateway locations, and respond more quickly to issues such as illegal dumping and vegetation overgrowth.

Caltrans has indicated that maintenance activities listed in the agreement would be eligible for reimbursement only if Caltrans has available funds upon reimbursement request. Caltrans has limited funds for ongoing maintenance at various locations each Fiscal Year and the funds are depleted quickly and therefore reimbursement is not guaranteed, and the City must be prepared to absorb the costs. The maximum authorized expenditures allowed by Caltrans quarterly is \$37,500 with a maximum annual expenditure of \$150,000.

Staff is currently in the process of preparing a Request for Proposals (RFP) for on-call maintenance services. In the meantime, the City Manager will utilize his administrative contracting authority to select an existing City contractor to provide maintenance services in support of the EDMA while the City completes its RFP process for on-call maintenance services. These maintenance services shall include landscape maintenance such as trimming overgrown grass, weeds, and shrubs; edging along sidewalks and fence lines; mowing; weed abatement; maintenance of planters and landscaping; and removal and disposal of clippings, debris, and bulky items from City properties.

#### FISCAL IMPACT:

Staff estimates the annual cost to maintain the ramps at \$150,000. The actual cost would be reimbursable by Caltrans based on Caltrans' available funding at the time of reimbursement request and is not guaranteed. Funding of \$150,000 is recommended in the proposed FY 2025-26 budget to cover these maintenance costs. If additional funding is required, staff will request the City Council to consider adding appropriations at a later time.
