APPEARANCES AND PRESENTATIONS

1. <u>Proclamation Declaring September 2023 as Deaf Awareness Month in the</u> <u>City of Commerce</u>

Director of Parks and Recreation. Mr. Alaniz. delivered а presentation. In response, Janelle Ocampo expressed her gratitude towards the dedicated parks and recreation staff for offering a diverse array of programs catering to children with hearing impairments. She shared that her daughter Samantha had the chance to participate in some of these programs, most notably embarking on her journey in extended her heartfelt thanks to volleyball. Ms. Ocampo the Citv for its commendable efforts.

Samantha Ocampo herself took a moment to convey her appreciation to both the City Council and the Parks staff for the numerous opportunities they had provided her.

Mayor Argumedo then proceeded to read an official proclamation.

4. <u>Approval of Minutes</u>

5. <u>Competitive Tree Planting Grant Program - First Amendment to Deed</u> <u>Restriction</u>

The City Council will consider for adoption a Resolution approving the First Amendment to the Original Deed Restriction related the City to of Commerce Tree Planting Project awarded through the LA Conservation Corps in the grant amount of \$200,000.00.

SCHEDULED MATTERS

6. <u>Presentation/Update from the Sheriff's Department Regarding Public</u> <u>Safety in the City of Commerce</u>

Sergeant Duarte presented a summary of the events and activities that occurred over the past two weeks. This included a homeless clean-up operation and an overview of the various meetings herself and Deputies had attended, such as the State of the City address and a town hall meeting at the Senior Center. Sergeant Duarte also reported attending a concert in the park, noting that there were no issues or incidents during the event.

In response to the presentation, Councilmember Lainez expressed appreciation for the comprehensive overview of the recent activities. Councilmember Lainez also inquired about the progress of the recruitment for the Public Safety Manager position, to which City Manager Cisneros responded that the recruitment process is still ongoing.

7. <u>Amending the Annual Operating Budget for Fiscal Year 2023-2024</u>

City Manager Cisneros indicated that although some aspects are still being finalized and discussions with the City Council are ongoing, there was a request for approval of certain timely capital outlay items. The remaining items would be

brought before the Council at a later date.

If the requested items were to be approved during tonight's meeting, it would result in a surplus of 5.7 million dollars.

The items that were requested for approval included personnel requests for a full-time Permit Technician. a full-time Code Enforcement Officer. a full-time Maintenance Specialist. two full-time Street Maintenance Workers. and two part-time Class Instructors. Additionally, funds would be allocated for a traveling team, capital outlay items such as furnishings for the library and Camp Commerce, as well as transportation items including a Ford Transit Van, a JCB compact track loader, two DAR electric vehicles, and an outdoor forklift. The total for these items amounted to \$785,190 dollars.

Councilmember Garcia moved, seconded by Vice Mayor Altamirano, to adopt resolution amending the annual operating budget for fiscal vear 2023-2024 in the amount of \$785,190, and as recommended by staff. The motion was carried by the following vote:

8. <u>Committee and Commission Appointments</u>

Councilmember Rebollo appointed Smyrna Caraveo to the Education Commission.

9. <u>Second Reading of an Uncodified Ordinance Approving a Development</u> Agreement Related to Application No. 18-052

City Manager Cisneros left the Council Chambers during this item. Director of Administrative Services and City Clerk provided a brief overview.

Councilmember Rebollo moved, seconded by Vice Mayor Altamirano, to adopt and reading conduct a Second Reading, by waiving the full and reading by title only, an Uncodified Ordinance approving the Development Agreement with DJCC Corporation (California Corporation) related to Application No. 18-052, for a commercial cannabis business at 5350-80 East Boulevard, Commerce CA, and direct staff to Washington prepare and file corresponding Notices of Exemption. The motion carried by the following

vote:

Councilmember Garcia had the pleasure of attending the Concert in the Park and described it as a very well organized event.

Councilmember Rebollo participated in the Contract Cities meeting and expressed her request for detailed information regarding Measure H, including the total amount of funds received and a breakdown of their allocation. She further expressed her intention to schedule a meeting with Sergeant and the public safety staff to gain a better understanding of upcoming public safety measures in the upcoming election. Councilmember Rebollo issued her condolences to Celia Hinojosa' family.

Councilmember Lainez shared his attendance at the Rosewood Park banquet for soccer athletes, the event hosted by Congressman Robert Garcia at the Senior Center, which he praised as a well-organized town hall meeting Councilmember Lainez also reported his attendance and praised well-organized the Concert in the Park.

Mayor Argumedo reported on his attendance at the town hall meeting organized by Congressman Robert Garcia, where he delivered a welcoming speech, and also his presence at the Summer Concert Series.
