CITY COUNCIL/SUCCESSOR AGENCY REPORTS

Councilmember Oralia Rebollo

1. Veterans Park: Apologized to the community and is committed to holding herself accountable to the promises made regarding the project. Thanked staff for working with what they have and will commit to the park's maintenance, the project's progress, and ensuring the community's quality of life is at the forefront of every decision for that park.

Councilmember Mireya Garcia

- 1. Veterans Park: Apologized for the condition of Veterans Park and stated that Council is working diligently to improve it.
- 2.. Discover the Art & Culture of El Salvador event at the Rosewood library: Thanked the staff for their hard work for the event and requested to be in contact with the artists that were on display.

Councilmember Hugo Argumedo:

- 1. Veterans Park: Provided updates on project and stated that the objective is to have a beautiful, state-of-the-art facility and a new park. Also mentioned a goal to establish a temporary location as soon as possible.
- 2. Fiestas Patrias event: Thanked the Parks and Recreation Department and organization staff for the event.

Mayor Pro Tem Kevin Lainez:

- 1. Veterans Park: Apologized for the state of Veterans Park and acknowledged concerns raised by the community. He stated that solutions are actively being sought for the promised facility. Emphasized that the park should be maintained like other City parks.
- 2. Homeless activity at alley along Jillson St. and Washington: Acknowledged the numerous complaints received from residents detailing the increased homeless activity overnight, illegal dumping, and safety issues. Requested more patrol and monitoring to the area.
- 3. Fiestas Patrias event: Thanked the Public Works, Public Safety, Library, Transportation, and Parks and Recreation Departments for their excellent work on the event.
- 4. Discover the Art & Culture of El Salvador event at the Rosewood library: Congratulated the library staff for the wonderful event, noting the great turnout and the successful collaboration with La Asociación de Salvadoreños en Los Angeles.
- 5. Reminded the community of the Commerce to College Fair and the grand

opening of the Bandini Library.
