

RESOLUTION NO.

**A RESOLUTION APPROVING PROFESSIONAL SERVICES AGREEMENTS
FOR VARIOUS ON-CALL PROFESSIONAL SERVICES**

WHEREAS, on-call service contracts provide flexibility and enhance the capacity of the Public Works and Development Services Department to deliver projects expeditiously and cost effectively; and

WHEREAS, on August 3, 2015, the City Council authorized staff to issue a Request for Statement of Qualifications (RFQ) for Various On-call Professional Services due to a high volume of current and anticipated capital improvement program (CIP) projects; and

WHEREAS, on August 25, 2015, staff advertised the RFQ for twenty different categories and, on September 4, 2015, received approximately two hundred Statements of Qualifications (SOQs); and

WHEREAS, on January 5, 2016, February 2, 2016, April 19, 2016, and May 3, 2016, the City Council approved on-call agreements (with a 3-year term) for the following disciplines:

- Landscape Architecture
- Park Planning and Design
- Building and Tenant Improvements Plan Check
- Landscape Architecture Plan Check
- Planning
- Environmental Science, Planning, Analysis & Assessment, and Regulatory Compliance; and

WHEREAS, staff recommends approving on-call professional service agreements (with a 3-year term) with the following firms under the "Geotechnical Engineering" category:

- American Geotechnical, Inc.
- Converse Consultants
- Geo-Advantec Inc.
- Ninyo & Moore
- Twining Geotechnical

WHEREAS, staff also recommends updating the current on-call professional service agreements (with a term of 3 years) to the following firms under the "Planning" category:

- Blodgett/Baylosis Environmental Planning
- Environmental Science Associates, Inc. (ESA)
- KTU+A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE DOES HEREBY RESOLVE AS FOLLOWS:

Section 4. The Professional Services Agreement between the City of Commerce and Ninyo & Moore for geotechnical engineering services, is hereby approved. The Mayor is authorized to execute the Agreement for and on behalf of the City.

Section 5. The Professional Services Agreement between the City of Commerce and Twining Geotechnical for geotechnical engineering services, is hereby approved. The Mayor is authorized to execute the Agreement for and on behalf of the City.

Section 6. The Professional Services Agreement between the City of Commerce and Blodgett/Baylosis Environmental Planning for planning services, is hereby approved. The Mayor is authorized to execute the Agreement for and on behalf of the City.

Section 7. The Professional Services Agreement between the City of Commerce and Environmental Science Associates, Inc. for planning services, is hereby approved. The Mayor is authorized to execute the Agreement for and on behalf of the City.

Section 8. The Professional Services Agreement between the City of Commerce and KTU+A for planning services, is hereby approved. The Mayor is authorized to execute the Agreement for and on behalf of the City.
