Parks and Recreation Director Lipton led the Pledge of Allegiance.

INVOCATION

Councilmember Rebollo offered the invocation.

APPEARANCES AND PRESENTATIONS

Certificate of Recognition for Public Works and Development Services
 Department for Receiving the 2017 Outstanding Local Streets and Roads

 Project Award from the League of California Cities.

Public Works and Development Services Director Babaki provided status update regarding some public works projects and grants received. Director Babaki stated that staff is in the process of implementing Utility Box Art Beautification project, Community Information meeting regarding Atlantic announced 2nd Safety and Beautification Improvement Project scheduled for April 27, 2017 at 5:30 p.m., Director Babaki announced award of two grants - the Sustainability Planning California Association of Governments Grant from Southern and 2016 SCAG Sustainability Award for Rosewood Neighborhood Connectivity Project.

Charles Herbertson congratulated staff and the City on the award for Estern Avenue Pavement Rehabilitation Project, and stated that the award recognizes the innovative programs. Mayor Altamirano and City Council also issued a Certificate of Recognition for their achievement.

2. <u>Commendation Honoring Vanessa Perez for Being Recognized as a 58th Assembly District 'Woman of the Year'</u>

Mayor and City Council commended Vanessa Perez for being recognized as a 58th Assembly District "Woman of the Year."

PUBLIC COMMENT

Library Director Sarmiento announced events scheduled for the National Library Week including Book Craft on Tuesday, April 13th, Donuts and Coffee with the Library Director, Dinner and Movie at Rosewood library, and other events.

Gloria Nezahualcoya asked whether there will be a voting place at Veteran's park. Interim City Administrator Rodriguez responded that double wide trailer is reserved for Election Day at the Veteran's park.

Animal Control Officers Colon and Orozco spoke about coyotes situation in the City. According to Officer Colon, one Commerce Casino employee was attached and there were three dog attacks. The City hired trapper and taking all necessary precautions. Officers asked residents not to feed coyotes and not leave food around.

SCHEDULED MATTERS

17. New City of Commerce Beautification, Branding and Way Finding

Simon Andrews, Principle of Graphic Solutions, and Chris McCambell, Project Manager/Designer for Graphic Solutions, provided presentation а regarding suggested branding and beautification the community. Initial stage implementation would include installation of banners throughout the City. The small scale model of the entry way monument was demonstrated to the public. Beautification Subcommittee members Baca Del Rio and Altamirano stated that consultants had great ideas, listened to subcommittee members input and came out with the great product.

According to Public Works Director Babaki, the Council could approve the initial stage of the program for banner installation, and staff will come back for approval with the following stages of the program.

Councilmember Leon moved, seconded by Councilmember Rebollo. to approve Resolution adopting new City pf Commerce beautification, branding way-finding efforts, and approve contract documents consisting Plans. **Specifications** and **Estimate** for Commerce Neighborhood Program and authorize advertisement of notice to invite bid, also approve of the City brand program including implementation of the neighborhood banners program. The motion carried by the following vote:

18. Green Zones Implementation Phase 1 - Status Update

Public Works and Development Services Director Babaki provided an overview of the staff report. Esmeralda Garcia, MIG consultant, stated that they are in a process of reaching out to the business community and understanding their concerns and bringing Green Zones concept to the business community. The purpose is to enhance existing businesses and attract future businesses. In order to gather the information from businesses the survey was developed and MIG consultant met with 30 businesses and Industrial Council. There was a previous partnership with Industrial Council and it is extended to the survey work that MIG is conducting. Ms. Garcia asked to support the proposal to initiate discussions with the business community and they already have a support from the Industrial Council. Discussion took place. This was informational item only.

19. Pavement Rehabilitation Project Design for FY 2017-18 and Authorization of Engineering Design, Geotechnical Investigation for Pavement Rehabilitation Program

Public Works and Development Services Director Babaki provided an overview of the staff report. Discussion ensued.

Mayor Pro Tem Baca Del Rio moved, seconded by Councilmember Leon, to adopt Resolution authorizing staff to proceed with the FY 2017/18 Pavement Rehabilitation Project Design utilizing previously approved \$2,500,000 CIP 2016 Council Meeting; authorize Transtech Engineers Inc. the June 21, to proceed with the necessary work for design services; and authorizing Geotechnical Investigation Services. The Geo-Advantec, Inc. to proceed with motion carried by the following vote:

20. Status Update Regarding Washington Boulevard Construction Project

Public Works and Development Services Director Babaki introduced key staff for the Washington Blvd project.

According to Director Babaki, the project is on scheduled and estimated to be below the budget. Director Babaki added that based on the size of this project, there were relatively small traffic interruptions, and they successfully coordinated with large agencies like Caltrans, SCE, BNSF, Cal-water and AT&T. Based on the 24 hour construction at the area of I-710, Councilmember Rebollo asked that the letters are sent to residents in addition to the notices posted. Ali Cair, Transtech Engineer, stated that contractor delivers notices to the properties effected.

Further discussion took place. Director Babaki explained that the project was estimated to take up to 27 months, and the project will be completed way ahead of time estimated.

21. Citywide Streetlight Pole Replacement Project

Director of Public Works and Development Services Babaki provided an overview of the staff report.

Mayor Altamirano asked whether staff is looking into replacing poles equipped with WiFi and solar power. Councilmember Leon stated that staff researched this before, and Council was informed that for future upgrades staff would need to negotiate with Edison in order to equip Light Poles with solar panels. Interim City Administrator Rodriguez added that having LED is cheaper than the regular poles, and at this time it would be good to revisit and look at different options. Director Babaki clarified that Edison owned poles are different than City owned poles and without Edison permission City cannot attach anything to those poles.

Councilmember Argumedo stated that the cost would be considerably more for the City if the City takes over those poles and maintains them. Mayor Pro Tem Baca Del Rio added that staff needs to compare with the surrounding communities.

It was a consensus among the City Council to gather more information and bring this item back for further discussion.

22. Bandini Park & Rosewood Park Preschool Room Dedication

Mayor Pro Tem Baca Del Rio stated that majority of Councilmembers talked and wanted to do this for a while. It was a consensus among the City Council on this proposal.

Councilmember Rebollo was very supportive of the preschool program. Following discussion, it was decided that staff will pick a date for dedication ceremony and invite students of those retired City employees Connie Ochoa and Alive Sterling for dedication ceremony.

Mayor Pro Tem Baca Del Rio moved, seconded by Councilmember Rebollo, to approve naming the Rosewood Park Preschool Room after retired City employee Connie Ochoa and naming the Bandini Park Preschool Room after retired City employee Alice Sterling. The motion carried by the following vote:

23. Renaming of the Council Chambers - "The Founding Chambers"

It was a consensus among the City Council to name Council Chambers as Founders Chambers.

Councilmember Leon moved, seconded by Mayor Pro Tem Baca Del Rio, to approve naming of the City's Council Chambers the "Founders Chambers." The motion carried by the following vote:

24. Consolidation of Election Precincts for the June 6, 2017, General Municipal Election

Administrative Services Director and City Clerk Shumway provided an overview of the staff report. Councilmember Argumedo suggested that precinct 1430030A is added to Bristow Park Precinct 143002A. It was noted that most residents that live on Ferguson could easier get to Bristow Park polling location than any other polling location. It was a consensus among the City Council to approve that suggestion.

There was no action taken on this item. It was receive and file only.

ORDINANCES

25. An Ordinance Approving the Transfer to Torrance Pipeline Company, LLC, of a Pipeline Franchise to ExxonMobil Oil Corporation - Second Reading

This item was continued to the next City Council meeting.

CITY COUNCIL/SUCCESSOR AGENCY REPORTS

Councilmember Rebollo thanked Parks and recretiona staff for decorations for Autism Awareness month. Councilmember Rebollo reported that she attended Community Services Committee at California League of Cities.

Councilmember Argumedo reported that he attended I-710 Committee meeting. Councilmember Argumedo stated that he was not able to attend Steven's Steakhouse parking issues subcommittee meeting, but he was made aware that some solutions were agreed upon and everyone were pleased with the result.

Councilmember Leon announced upcoming volunteer Spring Clean-Up scheduled for April 8, 2017 at 8 a.m. and also Egg Hunt scheduled at Rosewood Park April 15, 2017, at 10:00 a.m. and wished everyone blessed Easter.

Mayor Altamirano stated that he met with some Councilmembers from Santa Fe Springs, and they decided to create a Teen Mixer for teens in both communities.
