## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA, APPROVING AND RATIFYING THREE CONTRACTS FOR THE HOME PRESERVATION GRANT PROGRAM [PROJECT NO. 601074-16 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM]

WHEREAS, the City of Commerce receives Community Development Block Grant Program funding for the City's Home Preservation Grant Program (601074-16) to include home improvement activities involving, but not limited to the following items: new roofing, exterior paint, window replacement and other essential items; and
