Resolution of the Oversight Board to Commerce Community Development Commission Approving the Modification of Equipment and the South Coast Air Quality Management District (AQMD) Permit for Futernick Dump's Landfill Gas Collection System. Executive Director for the Oversight Board and Finance Director Domic stated that Board Member/City Administrator Rifa is retiring at the end of February and thanked him for his service and all the work he has done for this Board since 2012.

Executive Director Domic provided an overview of the staff report. Board Member Rifa stated that this was a prior Redevelopment Agency property and according to laws governing redevelopment it is the responsibility of the Agency to mitigate any contamination issues.

Discussion ensued about the lease term for the property, and the contamination. According to Executive Director Domic, the State did not provide a definite answer on how other agencies deal with the contamination issues when there is a lease for the property as well.
