COMMERCE, CALIFORNIA, APPROVING THE PROFESSIONAL SERVICES OF SYN-MAR ASSOCIATES TO PREPARE A REAL

ESTATE APPRAISAL REPORT

RECOMMENDATION:

It is recommended that the City Council approve professional services of Syn-Mar Associates to prepare a real estate appraisal report.

RELATIONSHIP TO STRATEGIC GOALS:

This agenda item relates to the 2016 Strategic Plan - Goal #6: "Enhance Quality of Life Goal"; as this project could increase parking capacity for transit operations; and provide the City with various options for future residential and/or business related opportunities.

BACKGROUND:

In an effort to obtain critical data deemed key for negotiations with Eastside Development Company, Council directed City staff to seek out the professional services of a qualified firm to obtain an appraisal for the following properties:

2500 S. Eastern Avenue, Commerce, CA, Assessor's ID No: 6335-024-046, 6335-024-042, 6335-024-038, 6335-024-043, 6335-024-044, 6335-024-0045, 6335-024-039, 6335-024-048; and 5505 E. Washington Boulevard, Commerce, CA, Assessor's ID No:6335-019-047.

ANALYSIS:

The scope of work includes the following deliverables:

 Prepare an analysis and value conclusions in a single narrative Appraisal Report that will be prepared in compliance with the Uniform Standards of Professional Appraisal Practice (USPAP); and • The comparable sales to be considered will be transactions involving vacant and/or redevelopment land in Commerce and the surrounding relevant market areas.

The City received four professional appraisal quotes for the properties referenced above.
