8. Refunding of the 2007 Tax Allocation Bonds

Assistant Finance Director Brook provided a brief overview of the staff report.

John Solarczyk stated that this approval will be the final step in refinancing of 87 million bond at 3%.

Councilmember Argumedo moved, seconded Councilmember by Mendoza. adopt Successor Agency Resolution approving a Form of Preliminary Official Statement in connection with the deliverv sale and its Allocation Refunding Bonds, confirming actions previously taken, Form Bond of **Bond Purchase Agreement:** making approval of a determinations relating thereto: and authorizing certain other actions in connection therewith. The motion carried by the following vote:

- **9.** Potential Reorganization of LAUSD Territory (Bristow area) to MUSD

Joanna Flores, MUSD Board Member, stated that MUSD Board is in full of support of this reorganization of Bristow area. Councilmember Soria noted that he started this process two years ago when residents expressed their interest in moving Bristow area from LAUSD to MUSD. Children would have access to all activities with the rest of the kids that attend MUSD, get access to transportation provided by the MUSD and would not experience gang activity.

Councilmember Soria moved. seconded by Councilmember Argumedo, to direct staff to prepare a Resolution and petition to be submitted to the Los Angeles County Superintendent of School to request reorganization of Bristow area. The motion carried by the following vote:

10. Commercial Refuse Management

Ron Saldana spoke in support of the staff recommendation and recommended non-exclusive franchise

Elizabeth Martinez spoke on behalf of Republic hauler and supported item #10 and recommended that their sub contractors are allowed to be consolidated under the one license held by Republic.

Nicole Kuklok -Waldeman, representing AAA Rubbish, stated that the City should hold all haulers in compliance.

Public Works and Development Services Director Babaki provided an overview of the staff report.

Discussion took place that the City Council would need more time and possibly a workshop needs to be scheduled for franchise agreement discussion.

It was a consensus among the City Council to move forward with the third notice regarding violation for non-compliant haulers.

Councilmember Soria moved, seconded Councilmember by recommended options by staff: modifying the Municipal approve **business** cease issuing additional licenses to recycling any haulers: assigning Republic a business license and consolidate all their subsidiaries one parent company to report as one hauler; mail through mail delivery a third and final notice to non-responsive prior to issuing a notice of suspension of their business license. The motion

carried by the following vote:

11. Commerce Golf Club Senior Discount Request

Parks and Recreation Director Lipton provided an overview of the staff report. Discussion ensued.

Councilmember Mendoza moved, seconded by Councilmember Soria, to approve the reinstatement of a Green Fees discount of 20% to resident senior members of the Commerce Golf Club. The motion carried by the following vote:

12. Agreement with Integrated Security Systems, Inc. to Purchase and Install a Video Security System for Camp Commerce

Parks and Recreation Director Lipton provided an overview of the staff report. Discussion ensued about location and liability and security aspect of cameras.

Councilmember Argumedo moved, seconded by Councilmember Mendoza, to adopt Resolution approving Agreement with Integrated Security Systems, Inc. for the purchase and installation of a video security system at Camp Commerce. The motion carried by the following vote:

15. Ordinance Changing Date of Election to March of Even-Numbered Years (Second Reading)

Administrative Services Director & City Clerk Shumway provided an overview of the staff report. Councilmember Argumedo moved, seconded by Councilmember Soria, to read the Ordinance by title only. Director Shumway read the title of the Ordinance. The motion carried by the following vote.

Councilmember Argumedo moved. seconded by Councilmember Soria, to 2 Ordinance amending Chapter 2.13 (Election date) Title (Administration and Personnel) to change General Municipal Election to the first Tuesday after the first Monday in March of each even-numbered years. The motion carried by the following vote:

16. Ordinance Addressing Aggressive and Unsafe Forms of Panhandling -First Reading

Assistant City Attorney Copado provided of the an overview staff report. ensued. Councilmember Mendoza Discussion recommended installina signs stating that panhandling is illegal per Commerce Municipal Code and rune effective enforcement program.

Mayor Pro Tem Altamirano moved, seconded by Councilmember Mendoza, to approve Ordinance for first reading adding Chapter 9.90 to Title 9 of the Commerce Municipal Code relating to the prohibition against certain forms of aggressive and unsafe panhandling." The motion carried by the following vote:

Councilmember Soria moved, seconded by Mayor Pro Tem Altamirano, to adopt an Interim Ordinance declaring and imposing a forty-five (45) day citywide moratorium on the establishment and operation of commercial cannabis activities authorized by the Adult Use of Marijuana Act. The motion carried by the following roll call vote:
