SUBJECT: An Ordinance Repealing and Replacing Chapter 6.06 – Garbage and

Refuse – first reading regarding Commercial Refuse Management and

Mandated Recycling Reporting

MEETING DATE: February 6, 2018

RECOMMENDATION:

For the City Council to:

- 1. Move to read the proposed Refuse Management Ordinance by title only to:
 - a. discontinue issuing recycling hauler licenses,
 - b. establish a single license for haulers of refuse and/or recycling services, and
 - c. require all haulers to pay a hauler license fee, and
 - d. transfer an existing and valid refuse and/or recycling hauler license to the parent company who acquired the licensed hauler for operating solely under the parent company name.
- 2. Approve the Ordinance for first reading, and
- 3. Set a Public Hearing date of February 20, 2018.
- 4. Direct staff to draft one of the following with procedures for implementation:
 - Option 1 semi-exclusive hauler agreement (maximum of 12 haulers)
 - Option 2 non-exclusive hauler agreement (all existing haulers)
 - Option 3 exclusive hauler agreement (one hauler for entire City)

Note: Selected agreement template would include specific reporting requirements for review and arrangements for conducting a formal bidding process.

BACKGROUND/ANALYSIS:

As previously reported, per state law, the City is responsible for preparing and submitting an Annual Recycling Report to CalRecycle to demonstrate compliance with all applicable recycling regulations. The Commercial Recycling Mandates have significantly increased staff's business outreach efforts, data gathering needs, and reporting responsibilities.

On April 24, 2017, staff presented a report to the City Council regarding commercial refuse management and the need to modify its commercial refuse collection system. The industry standard is to have one or at most, several exclusive franchise haulers under contract to

collect all refuse and recycling in a city following a competitive bidding process. This arrangement allows for a more manageable system of collection and reporting of mandated recycling information, consistent customer service, City involvement in rate setting, and establishment of contract terms such as condition and age of equipment and containers to prevent leakage and contamination of City public right-of-ways, specific reporting requirements, and franchise payments to the City.

On December 5, 2017, staff presented a report to the City Council regarding the status of CalRecycle's public hearing regarding the City of Commerce's non-compliance with Statemandated recycling reporting and with enforcement of the regulations on commercial haulers. At this meeting, Council approved the following:

- 1. Modifying the Municipal Code to cease issuing any additional business licenses to recycling haulers.
- 2. Assigning Republic Services a business license and consolidating all their subsidiaries currently licensed in Commerce for hauling refuse. *Note: NASA is now requesting the same consideration from the City.*
- 3. Mailing a 3rd and final notice with a 7 day time frame in which to report their recycling tonnages to non-responsive haulers prior to issuing a notice of suspension of their business license.

At this same meeting, Council directed staff to return with additional information regarding the three types of hauler agreement templates to choose from to place haulers under terms which would include reporting of recycling services.

Following the December 5, 2017 Council meeting, staff mailed via certified mail a Notice to Suspend and Terminate hauler licenses for those not complying with the mandated recycling reporting, namely to the following:

- 1. Goodwill Disposal Co., Inc.
- 2. Wilson's Metal Exchange, Inc.

In addition, three companies have been removed from the active hauler list since two are no longer in business (Belmont Fibers, Inc. and United Standard Pallet) and one allowed their license to expire on December 31, 2014 (City Fibers, Inc.). Staff also has continued reaching out to haulers to offer a one-time transfer of their business license to their parent company per Council direction. Staff subsequently received such a request from NASA who currently operates under Peerless' business license. NASA is the parent company and owner of Peerless. Once the Ordinance to amend the Municipal Code is effective, staff will transfer applicable licenses to the parent company and terminate the subsidiary licenses.

On December 28, 2017, the City received a CalRecycle-issued Compliance Order. The Order requires the following:

- 1. Development and submittal of a Local Implementation Plan (LIP) by March 2, 2018,
- 2. Implementation of the LIP by July 31, 2018,
- 3. CalRecycle monitoring of the City's LIP implementation through January 31, 2019, and
- 4. Quarterly and Annual Report submittals with implementation status updates.

As a result of the State-mandated regulations and Compliance Order, staff recommends Council direct staff to draft one of the following agreement templates and procedures for implementation:

- Option 1 semi-exclusive hauler agreement (maximum of 12 haulers)
- Option 2 non-exclusive hauler agreement (all existing haulers)
- Option 3 exclusive hauler agreement (one hauler for entire City)

The pros and cons are as follows:

Next Steps depending on Council's selected option

1. Draft agreement template for the awarded hauler(s) to provide both refuse and recycling services and include specific reporting requirements (except for Option 3 which would continue to separately license refuse and recycling services).

- Council presentation of agreement template for adoption and authorization to release a Request for Proposals for a formal bidding process. Notification of bidding procedures will be sent to all licensed haulers, advertised online via PlanetBids through the City's Department of Finance Purchasing Division, and in the local newspaper (all three options).
- 3. Bidding period of at least 30 days with sealed bids submitted to the City Clerks for a public bid opening which haulers may attend in person to obtain bid results (all three options). Bid results will be listed in PlanetBids also. Haulers do not need to attend the bid opening in person to receive bid results.
- 4. Staff review of bids and recommendation to Council.
- 5. Council approval of bid results and recommendation with award of agreement(s) to hauler(s).
