# Commercial Refuse Management Update

### Introduction –recycling mandates

#### The Law

- 1. Mandatory Commercial Recycling (AB 341) effective July 1, 2012
- 2. Mandatory Commercial Organics Recycling (AB 1826) effective January 1, 2016

#### The Impacts

- 1. Businesses that generate 4 cubic yards or more of refuse/week and
- 2. Multifamily residential 5 units or more.

#### **City Responsibilities**

- 1. Annual reporting to State (CalRecycle)
- 2. Obtain information from haulers including how many of their refuse customers the recycling laws apply to and the types and quantities of recycling material collected.
- 3. Enforcement of recycling laws.

# City Response

- Adoption of two ordinances to amend the Municipal Code.
- Outreach to all haulers and businesses over several years mailed recycling law notices and hauler reporting form.
- Regular follow-up with haulers to obtain recycling information.
- Annual reporting to State information obtained from haulers. Only approximately 10 out of 52 haulers reporting.
- Enforcement notices sent to non-reporting haulers.
- Staff presentation at CalRecycle public hearing on November 16, 2017 of City efforts to report and comply.
- On December 28, 2017, the City received a CalRecycle-issued Compliance Order requiring the following:
  - Development and submittal of a Local Implementation Plan (LIP) by March 2, 2018,
  - Implementation of the LIP by July 31, 2018,
  - CalRecycle monitoring of the City's LIP implementation through January 31, 2019, and
  - Quarterly and Annual Report submittals with implementation status updates.

- 6. City Fibers Inc. Business license expired on December 31, 2014
- 7. United Standard Pallet No longer in business

### Next Steps

#### **Recommended Direction:**

- Modify the Municipal Code to:
  - 1 discontinue issuing recycling hauler licenses,
  - establish a single license for haulers of refuse and/or recycling services, and
  - 3. require all haulers to pay a hauler license fee,
  - 4. Transfer a business license to the parent company and consolidate all their subsidiaries to allow for one parent company to report as one hauler up to six months following adoption of this Code change.
- Draft one of the following:

Option 1 – semi-exclusive hauler agreement (maximum of 12 haulers) Option 2 - non-exclusive hauler agreement (all existing haulers) Option 3 – exclusive hauler agreement (one hauler for entire City) (pros and cons of all options on next slide)

Note: selected agreement would include specific reporting requirements and a formal bidding process.

# Hauler Agreement Options

#### OPTION 1 – SEMI-EXCLUSIVE (maximum 12 haulers)

#### Pros

1. Achieves the original intent of the Municipal Code modified in 1984 to reduce to 12 haulers.

2. Fewer haulers to directly work with than current system.

3. Easier to manage outreach and reporting than current system.

4. Some City oversight - City can choose to negotiate specific rates and customer service standards or allow competition among the 12 haulers to set rates.

5. Businesses retain some choice.

6. Single license system.

#### Cons

1. Revocation of business licenses for many haulers. May use agreement terms to reduce number of haulers such as all haulers need to provide both refuse and recycling services. OPTION 2 – NON-EXCLUSIVE (all existing haulers)

#### Pros

1. Businesses have the most choices to service their refuse and recycling needs.

#### Cons

1. Too many haulers to manage for outreach and reporting causing non-compliance with State mandated recycling programs.

2. No City oversight in setting rates or customer service standards.

3. Two license and inequitable system – refuse haulers pay \$500/vehicle licensed + hauler fees (11% of gross receipts) and recyclers pay \$150/vehicle and no hauler fees. OPTION 3 – EXCLUSIVE (one hauler citywide)

#### Pros

1. Direct working relationship with one hauler.

2. Easy to manage outreach and reporting.

3. City involved in rate setting and customer service standards.

4. Single license system.

#### Cons

1. Requires a formal bidding process to select one hauler.

2. No competition for cost of service.

3. No choices for businesses.

# **Next Steps**

# Depending on Council's selection from Options

- Draft agreement template for the awarded hauler(s) to provide both refuse and recycling services and include specific reporting requirements (except for Option 2 which would continue to separately license refuse and recycling services).
- Council presentation of agreement template for adoption and authorization to release a Request for Proposals for a formal bidding process. Notification of bidding procedures will be sent to all licensed haulers, advertised online via PlanetBids through the City's Department of Finance Purchasing Division, and in the local newspaper (all three options).
- Bidding period of at least 30 days with sealed bids submitted to the City Clerks for a public bid opening which haulers may attend in person to obtain bid results (all three options). Bid results will be listed in PlanetBids also. Haulers do not need to attend the bid opening in person to receive bid results.
- Staff review of bids and recommendation to Council.
- Council approval of bid results and recommendation with award of agreement(s) to hauler(s).
