Edgar Negrete, representing Environmental Justice organization, spoke in support of item #13 regarding the rent control.

CONSENT CALENDAR

Councilmember Soria asked to pull item #8 for discussion.

City Administrator Cisneros provided an overview of the staff report, and stated that this contract would cover workload of the employee who is going to be on maternity leave. Councilmember Soria inquired whether workload could be redistributed between existing personnel without hiring a consultant. Further discussion ensued. It was a consensus to table this item

12. <u>Mid-Year Budget Review - Amending the Annual Operating and Capital Budgets for Fiscal Year 2017-2018</u>

Finance Director Domic provided an overview of the staff report. Discussion took place about the cultural excursion and allocating money ahead of time in the amount of \$36,000.

Councilmember Soria stated that employees need appropriate training and tools and purchase equipment right away in order to avoid repair costs. He cautioned about arbitrary decisions.

Mayor Rebollo moved, seconded by Councilmember Mendoza, to approve the mid-year budget including 36K allocation for cultural excursion. The motion carried by the following vote:

- 13. Written Report Regarding Ordinance Establishing Moratorium on Rent Increases Above Three Percent and Temporary Measures Protecting Residents from Evictions Without Just Cause

Deputy Director of Development Services Marquez provided an overview of the staff report. Discussion took place on what steps have been taken to help seniors. City Administrator Cisneros responded that they met with the association, and got information as far as structure of the rent at the facility and some of the tools the City might have in order to assist the senior. Those rents in the facility are controlled by HUD and federal programs. Staff is working on the pilot program to assist seniors.

Councilmember Mendoza asked that the town hall meeting is scheduled, and recommended that the message is sent the property owners. Further discussion ensued.

City Administrator Cisneros stated that staff is considering limit the impact to just three different complexes in the City, and staff reached out to those complex building owners and informing those property owners about proposed solutions.

14. Ordinance Addressing Illegal Dumping - First Reading

Assistant City Attorney Copado provided an overview of the staff report. Discussion took place regarding fines, and Assistant City Attorney Copado stated

that administration citation program will be brought to the City Council for consideration.

Councilmember Soria moved, seconded by Councilmember Argumedo, to read the Ordinance by title only. Administrative Services Director and City Clerk Shumway read the title of the Ordinance adding Chapter 6.21, "Illegal Dumping" to Title 6, "Health and Sanitation" of the Commerce Municipal Code Establishing Prohibitions Against Illegal Dumping. The motion carried by the following vote:
