

AERIAL VIEW (FERGUSON DRIVE FROM SAYBROOK AVE. TO GARFIELD AVE.)

→ REMOVE EXISTING "NO TRUCKS OVER 3 TONS" SIGN

➔ INSTALL PROPOSED "NO COMMERCIAL VEHICLES" & "LOCAL TRAFFIC ONLY" SIGNS → INSTALL PROPOSED "NO TURN FOR COMMERCIAL VEHICLES" SIGN

ALL PROPOSED NEW SIGNS TO BE 4' X 4' IN SIZE EXCEPT NOTED.


