Outgoing Mayor Rebollo and Mayor Pro Tem Altamirano were recognized for their leadership and contributions during 2017-2018.

Antonio Chavez from Hilda Solis office provided certificates to outgoing Mayor Rebollo and Mayor Pro Tem Altamirano.

Mayor Argumedo recognized former Councilmember Bob Ula, Joe Arguilar, Jesus Cervantes, Ray Gordy Cisneros, Joanna Flores, School Board Member, Edgar Cisneros who is Board Member of Unified School District. his kids and granddaughter. Mayor Argumedo stated that he was first elected in November 1996 and since that time the following projects came to fruition: Rosewood community Center, Acquatics Center, Senior Center, Transportation Centre, Crown Plaza Hotel, Citadel expansion project, Education Commission was established Transient Lodging and restructured scholarship program, and also Tax was passed. Mayor Argumedo stated that he is committed to work hard as the Mayor for the upcoming year.

Mayor Pro Tem Soria thanked everyone and stated that it is exciting opportune and acknowledge his wife Maryam Soria, kids and grandmother, and mother.
