Mayor and Councilmembers recognized Sonia Bautista for receiving the 2018 Arnulfo Trejo Librarian of the Year award.

PUBLIC COMMENT

Kevin Larsen, President of the City of Commerce Association, spoke regarding Union proposal and their main priorities for the contract.

Mayor Argumedo stated that there is a good contract right now in place for employees and residents and everyone involved. City Administrator Cisneros stated that the City needs a contract that would offer City a stability. The current proposal received from the union is 8 times more than the previous proposal.

CONSENT CALENDAR

Item #16- Discussion took place.

Councilmember Mendoza moved, seconded by Mayor Pro Tem Soria, to adopt Resolution authorizing GSI Environmental to provide services, subject to an existing on-call Services Agreement related to Specific Plating and Remediation Project and conduct a Water Quality Assessment. The motion carried by the following vote:

Item #23 - Discussion took place that the City of Commerce receives a small percentage of the money allocated, and the allocation is based on the population.

According to Councilmember Soria, it would be better if this funding is brought back to voters for consideration. Councilmember Altamirano stated that staff needs to send letters to all representatives regarding money distribution. There was a consensus among the City Council to direct staff to send letters.

Mayor Pro Tem Soria moved, Councilmember Altamirano seconded, to reject staff's recommendation and direct staff to write letters to legislators regarding money allocation distribution. The motion carried by the following vote:

Public Works and Development Services Director Babaki provided an overview of the staff report. Discussion took place on traffic count, and accident data and how that data justifies installation of the stop sign. Director Babaki stated that the Council could direct staff to place a stop sign. Further discussion took place regarding quality of life, and the City Council requested a more accurate data for traffic count.

It was a consensus among the City Council to table this item to a later date, and

request more traffic count data and provide the City Council with more information on guidelines for stop sign installation.

Discussion took place regarding sidewalk at Ferguson. Councilmember Rebollo recommended that the community is polled and do what the majority want whether stall sidewalks or leave as is. It was a consensus among the City Council to check and survey the community first.
