RE: *Disabled Blue Curb Parking Space Request – DENIED*

Dear Resident / Homeowner:

Your application for a disabled blue curb parking space request was reviewed by City staff and has been *denied* due to one or more of the following reasons:

- ☒ Applicant's driveway has ample length (20 feet or more) and / or width (14 feet or more) and can be used for access by the physically challenged.
- ☐ Applicant's driveway can be widened to accommodate access by the physically challenged.
- ☒ Applicant has a garage of sufficient size to accommodate physically challenged person's vehicle.
- ☐ Applicant's request for a disabled blue curb parking space is for temporary use and not for long term nature.
- ☐ Applicant's request for a disabled blue curb parking space cannot be installed due to space limitations or geometric restrictions in front of or near your property.
- ☐ Applicant's request for a disabled blue curb parking space is in close proximity to a curb ramp. (Curb ramps are those ramps located at most street corners).
- ☐ An existing or more than one existing disabled blue curb parking space is in the vicinity of the applicant's request. Space considerations must be considered and cannot allow for multiple disabled blue curb parking spaces.
- ☐ Applicant has a past history or record of abusing or misusing disabled blue curb parking privileges.

REQUEST TRAFFIC COMMISSION REVIEW:

If you *disagree* with Staff's denial of your application for a disabled blue curb parking space, you may request to have your case heard in front of the City of Commerce Traffic Commission, which meets on the second Wednesday of each month in the City Council Chambers at 6:30 P.M.

Staff will present your case to the Traffic Commission (Commission), and you will have the opportunity to express your views, opinions, and concerns to the Commission. The Commission is not obligated to accept Staff's recommendation, and the Commission is free to decide whether or not to grant you the disabled blue curb parking space.

If the Traffic Commission does not rule in your favor and denies your request, you have one more opportunity to appeal to the City Council.

If you wish to have your case heard in front of the Traffic Commission, please fill out the information below, sign and date, and return to the address shown below.

Once received, Staff will schedule your case for the next upcoming Traffic Commission meeting. *You will be invited and notified of the date, time, and location of this meeting.*

You **MUST** respond within ten (10) business days from the date of this letter if you wish to have a Traffic Commission review, after which, the City's decision to deny your blue curb request becomes final.
