SUBJECT:	Sign Installation for No Overnight Parking and	Street Sweeping
MEETING DATE:	August 14, 2018	

### **RECOMMENDATION:**

Staff requests the Measure AA Advisory Committee recommend to the City Council approval of a \$81,741.94 appropriation (inclusive of a 15% contingency) for the installation of 690 no overnight parking and street sweeping signs on designated streets in the City of Commerce in order to address public safety and health hazard issues due to excessive overnight parking on certain streets.

### **BACKGROUND:**

On June 5, 2018, City Council approved "No Overnight Parking" sign installations on specific streets in the City of Commerce impacting the public safety and hygiene of certain streets and the overall neighborhood. Temporary signs were installed on four streets as shown below to begin enforcement until which time permanent sign installation can occur.

On July 3, 2018, City Council approved installing the same signage to additional streets experiencing an increased number of vehicles parking for an excessive period of time. Parking would be prohibited during the hours of 2:00 A.M. and 6:00 A.M. and restricted, as posted, for street sweeping along the following streets:



- 1. Olympic Boulevard (between Goodrich Blvd. & Gerhart Ave.) temporary signage installed
- 2. Union Pacific Avenue (between Goodrich Blvd. & Gerhart Ave.) temporary signage installed
- 3. Goodrich Boulevard (between Ferguson Dr. & Whittier Blvd.) temporary signage installed
- 4. East 61st Street (between Eastern Ave. & end of street) temporary signage installed
- 5. Elm Street (between Garfield Ave. & Vail Ave.)
- 6. Sycamore Street (between Vail Ave. & city limit)
- 7. Condor Street (between Vail Ave. & Supply Ave.)
- 8. Tanager Avenue (between Sycamore St. & Condor St.)

9. Supply Avenue (between Sycamore St. & Condor St.) 10. Noakes Street (between Bonnie Beach Pl. & Herbert Ave.) 11. Telegraph Road (between Marianna Ave. & Atlantic Blvd.) 12. Parking enforcement has begun in areas with permanent and temporary signage was installed.
