SUBJECT: Resolution Adding Goodale Architecture Planning to the On-Call

Professional Services list for Architectural Engineering, Planning

Services, and Building and Facilities Assessment

MEETING DATE: September 18, 2018

RECOMMENDATION:

Adopt a Resolution Adding Goodale Architecture Planning to the On-Call Professional Services for Architectural Engineering, Planning Services, and Building and Facilities Assessment.

BACKGROUND AND ANALYSIS:

The On-Call Professional Services Agreement for Architectural Engineering List was first approved by the City Council on June 20, 2017 under Resolution No. 17-62 with a three year contract term. The list was augmented on August 2, 2017, under Resolution No. 17-79 adding Kluger Architects, Inc. to said category. There are seven firms currently on the on-call list.

The award of the On-Call Professional Services Agreement for Planning Services was first approved by the City Council on January 5, 2016 under Resolution No. 16-08 with a three year contract term. The list was updated on April 4, 2017, under Resolution No. 17-24 with the following firms on the list – Blodgett Baylosis Environmental Planning, Environmental Science Associates, Inc., and KTU+A. The list was further updated on June 20, 2017, under Resolution No. 17-62, adding Moore Iacofano Goltsman, Inc. and on May 1, 2018, under Resolution No. 18-55 adding CSG Consultants, Inc. and ejma Planning + Development to said category. There are six firms currently on the on-call list.

The award of the On-Call Professional Services Agreement for Building and Facilities Assessment was approved by the City Council on June 20, 2017 under Resolution No. 17-62 with a three year contract term. There are eleven firms currently on the on-call list.

The purpose of on-call professional service agreements is to provide the City with flexibility and enhance the City's capacity to deliver projects and programs expeditiously while also reducing costs by curtailing the time and effort to solicit various proposals for different projects.

During the term of the on-call agreement, some of the firms are either unresponsive and/or their fees are too high. Therefore, staff would like to have an extensive list of firms for more flexibility and better pricing. Staff therefore recommends Goodale Architecture Planning be added to the current on-call list for Architectural Engineering, Planning Services, and Building and Facilities Assessment.

FISCAL IMPACT:
