

RESOLUTION NO.18-XX

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE,
CALIFORNIA, AUTHORIZING THE SUBSTANTIAL AMENDMENT OF
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR FISCAL
YEAR 2018/2019**

WHEREAS, the Community Development Block Grant (CDBG) Program has operated since 1974 to provide local governments with resources to meet the needs of persons of low to moderate income; and

WHEREAS, the City of Commerce contracts with the Los Angeles County Community Development Commission for disbursement of CDBG Funds, through the Small Cities Program; and

WHEREAS, the City of Commerce received a total of \$119,311 of CDBG Funds for the 2018/2019 Fiscal Year and has a total of \$115,641 of prior year's funds for a grand total of \$243,952 to allocate toward projects; and

WHEREAS, the City Council passed Resolution No. 18-14 on February 6, 2018 approving the 2018/2019 CDBG project funding; and

WHEREAS, the City of Commerce will substantially amend the 2018/2019 CDBG project funding to include the cancellation of the City's ADA Accessibility Improvements – Curb Ramps in Bristow/Northwest Area (601990-18) and the reallocation of this project's funding of \$111,832 and allocation of \$3,809 of rollover funds, as a result of unexpended 2017-2018 for a total of \$115,641, to the City's existing Home Preservation Grant Program (601074-18). The Home Preservation Grant Program's total funding amount will be increased to \$210,641 for FY 2018-2019.

WHEREAS, the City Council has conducted a public hearing and the required prior noticing to provide the public an opportunity to comment on the 2018/2019 CDBG Substantial Amendment; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE DOES HEARBY RESOLVE AND ORDER AS FOLLOWS:

Section 1: The City Council approves the Community Development Block Grant (CDBG) Program Substantial Amendment for Fiscal Year 2018/2019 and instructs staff to submit the necessary documents and a copy of this Resolution to the Los Angeles County Community Development Commission for approval of the 2018/2019 CDBG Substantial Amendment as follows:
