A RESOLUTION RENEWING THE ON-CALL PROFESSIONAL SERVICES AGREEMENTS FOR LANDSCAPE ARCHITECTURE, LANDSCAPE ARCHITECTURE PLAN CHECK, AND PARK PLANNING AND DESIGN

WHEREAS, the on-call professional services agreements for Landscape Architecture, Landscape Architecture Plan Check, and Park Planning and Design was approved by the City Council on January 5, 2016 under Resolution No. 16-08; and

WHEREAS, the approved firms/consultants are the following::

WHEREAS, the on-call agreements have a three-year term with an option to extend the agreement if both parties agree under Section 7.2 of the Agreement; and

WHEREAS, both parties agreed to extend the agreement and exercise the provisions in Section 7.2 of the Agreement; and

WHEREAS, as part of the renewal, a supplemental questionnaire on the firm's Criminal Convictions, Non-Collusion Declaration, Civil Litigation History, and False Claims, is added as a requirement, a new fee proposal was submitted by the consultants and was reviewed and accepted by the Director of Public Works and Development Services, and a new template for the renewal agreement is also used; and

WHEREAS, the amendments to the renewals were permitted through Section 7.3 of the original Agreement; and

WHEREAS, staff recommends that the on-call professional services agreements for the Landscape Architecture, Landscape Architecture Plan Check, and Park Planning

and Design be renewed for another three years, with a contract term of January 5, 2019 through January 4, 2022.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The renewal for the on-call professional services agreement for the Landscape Architecture, with a contract term of January 5, 2019 through January 4, 2022, is hereby approved.

Section 2. The renewal for the on-call professional services agreement for the Landscape Architecture Plan Check, with a contract term of January 5, 2019 through January 4, 2022, is hereby approved.

Section 3. The renewal for the on-call professional services agreement for the Park Planning and Design, with a contract term of January 5, 2019 through January 4, 2022, is hereby approved.

Section 4. The Mayor is authorized to execute the Agreements for and on behalf of the City of Commerce.
