Public Works and Development Services Director Babaki and Deputy Director of Engineering Yang provided an overview of the staff report regarding traffic control and public safety efforts during black Friday event at Citadel Outlets. Mayor Argumedo asked to bring back enforcement of illegal parking in residential Councilmember Rebollo recommended utilizing traffic neiahborhoods. company for traffic control and utilize CSOs for residential parking enforcement. Further discussion took place about barricades in the residential neighborhoods. Councilmember Soria added that traffic control plan needs to be presented to the City Council earlier, so any recommendation could be incorporated. Sargent Hernandez explained why CSOs were utilized for traffic control.

Councilmember Rebollo moved, seconded by Councilmember Mendoza, to receive and file a report regarding the recent 2018 Citadel Outlets' Moonlight Madness / Black Friday sales event. The motion carried by the following vote:

14. <u>Status Update on Power Outages in Veteran's Park Neighborhood</u>

Sal Ramirez, Government Relation Manager, talked about the circuit in Veteran's area, and reasons for recent power outages. Mayor Argumedo and the City Council expressed concerns that the outages were for a long time and it is effecting residents. Some residents had broken appliances due to power outages and spoiled food. Mr. Ramirez stated that residents could file a claim and be Discussion took place about marketing and reimbursed for the lost items. customer service and reaching out to people that are effected. Sal Ramirez stated that customers can call and information could be disseminated to everyone. Mayor Argumedo requested that the copy of the incidents provided to the City Council and what was done to correct those deficiencies that caused power outage. In addition, Councilmember Rebollo recommended not having planned outage in the area that already had so many power outages.

Councilmember Rebollo thanked Commerce Casino for the Holiday Cheer Program, and congratulated Unplugged on their recent "Hairspray" performance. Councilmember Rebollo stated that the Camp Commerce Holiday Santa Village celebration was outstanding event, and asked staff to look into adding more weekends for this event in December or November.

Councilmember Altamirano thanked Commerce Casino for generous contributions, and stated that the Christmas Tree Lightening was an amazing event.

Councilmember Mendoza reported that he attended Bristow park football banquet, attended Children's Holiday party, Bandini park football banquet, Traffic Commission, Neighborhood Watch meeting, Unplugged performance, and Royal Tea party. According to Councilmember Mendoza, residents were concerned and reported graffiti at Bristow park.

Mayor Pro Tem Soria stated that this was a great year for Commerce and thanked staff members for the good job, and wished employees and residents Happy New Year.

Mayor Argumedo thanked Commerce Casino for all contributions and wished residents and staff Happy New Year.
