**SUBJECT:** APPROVE ALLOCATON OF \$265,000 FOR THE AWARD OF AN ARCHITECTURAL AND ENGINEERING CONTRACT TO KOA, CORP. FOR THE FEASIBILITY STUDIES AND PREPARATION OF PROJECT PLANS, SPECIFICATIONS, AND ESTIMATES (PS&E) FOR THE SIDEWALK CONNECTIVITY, AND STREET IMPROVEMENT PROJECT FROM GAGE AVENUE TO TELEGRAPH ROAD

### **RECOMMENDATION:**

Approve allocation of \$265,000 of Measure AA funds to award an Architectural and Engineering contract to KOA Corp. for the feasibility studies and preparation of plans, Specifications, and Estimate (PS&E) of the sidewalk connectivity and street improvement project from Gage Avenue to Telegraph Road.

### **BACKGROUND:**

The location of I-5 and Slauson Avenue serves as one of the major gateways to the City of Commerce. There are a number of retail businesses and hotels and motels that are located along Slauson Avenue, Gage Avenue, and Telegraph Road that serve the visitors and residents. However, despite such assembly of retail businesses, the area suffers from poor pedestrian and bicycle connectivity and circulation. While the proximity of the freeway as well as entrance and exit ramps enhances the desirability of the area, it also impedes pedestrian and bicycle access. This is further exacerbated by the presence of the Union Pacific Rail lines in the area which further restricts the pedestrian flow.

### **ANALYSIS:**

In order to address the long standing issues in the area, Public Works and Development Services staff issued a Request for Proposals for the analysis, identification of

engineering solutions and preparation of contract documents for the ultimate design at this location on September 18, 2018.

The proposals were received on October 19, 2018. The following four firms responded to the RFP: CSG, Elie Farah, JM Diaz and KOA. Staff reviewed and analyzed the proposals based on the following evaluation criteria:

- 1) Compliance with the RFP Requirements, Proposal Quality
- 2) Project Understanding, Approach, Methodology, including responsiveness, flexibility
- 3) Experience of Assigned Staff, including prior experience of working relationship of key team members in the past
- 4) Similar Project Experience
- 5) Schedule Efficiency
- 6) Cost Effectiveness

Staff evaluated the proposals based on the above ranking criteria, and KOA was determined to be the highest ranked firm. The KOA requested fee for the project is in the amount of \$240,138 (see attached). Staff requests recommendation for allocation of \$265,000 as follows:

Measure AA Committee approved recommendation of this allocation at its meeting of February 12, 2019.
