**CALL TO ORDER**

*Mayor Argumedo called Special City Council meeting to order at 4:09 p.m. in the Council Chambers.*

**PUBLIC COMMENT**

*There were no individuals wishing to address the City Council on any items within their jurisdiction.*

**1. Presentation by Willdan Financial Services on the Feasibility Studies  
Regarding Development Impact Fee Study and the User Fee Study**

*Discussion took place about the impact fees for residential and multi use units and whether the impact fees would hinder the development in the City. In response to Mayor Argumedo question regarding the pavement cost, and how to recover those cost, it was stated that the impact fees only one time use, and could not be used as reoccurring costs.*

*It was stated that about 75% of cities in California have fees in place, and some examples are City of Murrieta, City of Temecula, City of Freemont, City of Oakland, and City of Berkley.*

*There was a presentation provided regarding user fees, and those proposed fees are comparable with the surrounding cities. Staff also separated residential; and non-residential fees. According to Direcotr of Public Works and Development*

*Services Babaki, this presentation is more intended to provide more information, and see what level the City Council would like to implement fees.*

*Gloria Nezahualcoya stated that implementing fees could make it too expensive for the residents.*

*City Administrator Cisneros stated that this is receive and file. This item will be brought back at a later time.*

*Ester Luis, City's Housing consultant, provided a brief overview of the staff report. In response to Councilmember Rebollo's question, Ms. Luis stated that the ADA improvements have been already completed using other funds.*

*Mayor Argumedo opened Public Hearing. There were no individuals wishing to speak. Mayor Argumedo closed Public Hearing.*

**Councilmember Mendoza moved, seconded by Councilmember Rebollo, to adopt Resolution authorizing the substantial amendment to the 44th year of Community Development Block Grant (CDBG) funds for Fiscal Year 2018/2019. The motion carried by the following vote:**

18. Ordinance Establishing Commerce Community Choice Aggregation and Approving Implementation Plan and Statement of Intent -First Reading

*Director of Economic Development and Sustainability Bobadilla provided an overview of the staff report.*

*..... provided power point presentation. According to ....., the City is responsible for buying the energy and billing and maintenance. Energy cost would become cheaper for residents and it would generate revenues for the City.*

**Councilmember Rebollo moved, seconded by Mayor Pro Tem Soria, to read the Ordinance by title only, and introduce for first reading an Ordinance establishing Commerce Community Choice Aggregation and Approving Implementation Plan and Statement of Intent. Administrative Services Director and City Clerk Shumway read the title of the ordinance. The motion carried by the following vote:**

## **SCHEDULED MATTERS**

**19. Discussion of the Impacts of California High Speed Rail Project in the City of Commerce, Visioning and Recommendations for Mitigation Impacts and Benefit Enhancement**

*Public Works and Development Services Director Babaki provided an overview of the staff report. Director Babaki stated because of the tremendous effect on the City of Commerce imposed by this project, Metro needs to consider providing certain substantial benefits in return.*

*Yvette Karen, Engineer and Executive Director for JPIA, provided a presentation for recommended improvements for the High Speed Rail.*

*Discussion took place about potential loss of revenue, and possible solution in order to mitigate effects on the residents and the community. Further discussion took place about 64 parcels being affected and that the City as the most affected City should get attention and some feasible solutions.*

**Councilmember Mendoza moved, seconded by Mayor Pro Tem Soria, to authorize staff to engage with the California High Speed Rail Authority to advance the recommendations: (1) Relocate Metrolink Station over I-5 Freeway; (2) Provide Active Transportation and Vehicular Connectivity; (3) Provide a Buffer area; (4) Provide a First-Last Mile connection to the Citadel; and (5) Request that CHSRA delay the release of the draft EIR. The motion carried by the following vote:**

**20. Proposed Fees for the Use of Electric Vehicle Charging Stations Located Adjacent to City Hall**

*Transportation Director McFerguson provided an overview of the staff report. Discussion took place whether to provide charging stations for free for the residents and non-residents paying a fee, and how resident use would be differentiated from non-resident. Director McFerguson stated that the more layers they add it is harder to manage. Mayor Argumedo recommended adding other locations within the City, and more options/locations available for charging electric vehicle within the City.*

**Councilmember Altamirano moved, seconded by Mayor Pro Tem Soria, to adopt Resolution approving the following fees: a free-of charge for the first two hours, and \$2.00 per hour thereafter for public use of the new Electric Vehicle charging stations located adjacent to City Hall. The motion carried by the following vote:**

**21. Commerce Water Polo 14u Team Sponsorship Request**

*Parks and Recreation Department Director Lipton provided an overview of the staff report. Discussion took place.*

**Councilmember Rebollo moved, seconded by Mayor Pro Tem Soria, to approve sponsorship from City Council for the Commerce Boys & Girls 14u Water Polo Teams to attend the 2018 USA Water Polo Age Group Championships Cup November 2-4, 2018 in Bloomington, Indiana in the amount of \$9,410. The motion carried by the following vote:**

**22. Rescheduling of November 6, 2018, Regular City Council Meeting**

**Councilmember Rebollo moved, seconded by Mayor Pro Tem Soria, to reschedule Tuesday, November 6, 2018, Regular City Council meeting to November 13, 2018, due to General Election. The motion carried by the following vote:**

**23. Discussion and Consideration of Human-I-T Partnership Request**

*Mr. Gabriel Middleton, Human IT, provided an overview of the staff report.*

*Discussion took place about benefits this program would bring for the residents. In response to Mayor Argumedo's question of how the program would be managed and monitored, City Administrator Cisneros responded that Human IT would coordinate with the City's Information Technology division, develop a measuring tool, and monitor how many people going through the program. Councilmember Rebollo recommended utilizing social services data to be able to identify families that are good candidates for participation in this program.*

*Marc Adams spoke in support of the program, and also recommended that by-weekly computer training is offered in Senior Center and promote in schools.*

Councilmember Rebollo moved, seconded by Mayor Pro Tem Soria, to allocate 100k for Human-I-T's request to partner on a worthwhile digital inclusion initiative and workforce training program that empowers underserved populations in the digital age. The motion carried by the following vote:

#### **CITY COUNCIL/SUCCESSOR AGENCY REPORTS**

*Councilmember Altamirano spoke about potential loss in revenue from Casino and how it would affect the City of Commerce.*

*Councilmember Rebollo invited community to participate in Club 21 Walk scheduled for October 20, 2018 and asked anyone interested to donate for Team Jack. Councilmember Rebollo stated that she had a recent conference call with DTSC, and a lot of homes (about 63 homes) in Commerce getting cleaned up. However, there is no funding still available for tier 2 group. Councilmember Rebollo reported that she attended COG meeting.*

*Councilmember Mendoza reported that he attended Vector Control meeting.*

*Mayor Pro Tem Soria congratulated Unplugged participants for their recent performance.*

*Mayor Argumedo reported that he attended Unplugged Performance, went to Sacramento with Councilmember Altamirano to voice concerns about the importance of the gaming issues and how it relates to the City. The proposed changes to gaming could result in 16 million revenue loss for the City, which would drastically effect City programs.*
