PUBLIC COMMENT

Sandra Enriquez, Laura Logan, Daniel Escobar, Alexandria Modnado, Terry Westmore, Maryam Griego -Tally, Pete Schneuffer, and Damien Mendoza asked that the City works with the City Employee Association on the contract that satisfactory to both sides.

Mayor Argumedo stated that the City Council feels the same way as the employees.

Deputy Director of Engineering Yang provided an overview of the staff report. Discussion ensued. Councilmember Mendoza asked that for these types of reports a break-down is provided, work performed is itemized and costs itemized.

Ordinance for the New Development at 6800 East Washington Boulevard

Associate Planner Molinar-Esparza provided an overview of the staff report. Bridget Herdman, Herdman Architecture and Design, spoke about the proposed art piece design.

Discussion took place about the art piece design and warehouse intended uses. According to Ms. Herdman, art piece is conceptual and it complements the area.

Rebollo Councilmember moved, seconded by Mayor Por Tem Soria. to adopt Resolution approving the Public Art proposed by the property owner, North Palisades Partners LLC, the project site located 6800 East at at Washington Boulevard in accordance to the Art in Public Places Ordinance. 12. <u>Installation of Designated Veterans and "Heroes" Parking Spaces and</u> Signs at Various City Facilities

Deputy Director of Engineering Yang provided an overview of the staff report. Discussion ensued about the concept and alternatives, and enforcement.

Mayor Argumedo recommended adding American Flag instead of the star on the sign. It was a consensus among the City Council to dedicate two parking spaces at the library parking lot and use two dedicated Councilmembers parking spaces for Veteran's parking.

ORDINANCES

14. <u>An Ordinance Relating to Licensing and Operating Regulations for</u> <u>Home-Sharing - First Reading</u>

Assistant City Attorney Copado provided an overview of the staff report. Councilmember Mendoza asked whether there is an issue with the short-term rentals, to which City Administrator responded that it is on a smaller scale than bigger cities. However, this regulation provides opportunity for future enforcement should the issues arise more frequently. Most of issues deal with the noise, and that is why the owner is required to be at the property to deal with any issues. Discussion took place about the enforcement.

Assistant City Attorney Copado stated that there is lack of provisions in the Municipal Code to enforce any of those matters and if the problem becomes worst in the future that we have something in the books. City Administrator Cisneros stated that it is a quality of life concern.

Councilmember Rebollo moved, seconded by Mayor Pro Tem Soria, to introduce Ordinance of the City of Commerce amending Chapter 3.10 and City of adding Chapter 5.63 of the Commerce Municipal Code relating to licensing and operation regulations for home-sharing, and read the ordinance by title only.

15. <u>An Ordinance Amending Chapter 2.04 (City Administrator) of the</u> Commerce Municipal Code - First Reading

This item was heard after the consent calendar.

City Administrator Cisneros provided an overview of the staff report and stated that this Ordinance is again agendized for first reading.

Councilmember Mendoza stated that originally he posed a question about the differences between Administrator and City Manager, and did not receive a complete answer. Assistant City Attorney stated that this ordinance was not prepared by this office. in addition, Assistant City Attorney Copado clarified that this authority is granted to City Manager and sentence was added in paragraph two to indicate that City Manager would not have an authority or ability to do this on his own unless the City Council also voted by majority vote.

Discussion ensued about the powers of authority of hiring and firing of executive staff. City Administrator Cisneros stated that it would be shared responsibility between the City Manager and City Council, and would not preclude the City Council in decision for hiring and firing.

Mayor Argumedo agreed with Councilmember Mendoza, and stated that he believes that Council should be making those decisions, and try to bring the best qualified people for leadership positions.

Councilmember Altamirano recused himself from participating in the meeting at 7:08 p.m.

Councilmember Altamirano agreed with previous remarks made and suggested adding that in the ordinance for having shared responsibility on hiring and firing of executive positions.

Councilmember Rebollo stated that the City Council should be staying away from personnel matters. Further discussion took place. Mayor Argumedo recommended tabling this item to a later date.

Councilmember Altamirano moved. Councilmember seconded by Rebollo, to read the ordinance by title only, and introduce Ordinance of the City of Commerce amending Chapter 2.04 as described to change the title of the City Administrator to City Manager and assign City Manager with cities responsibilities and authority more consistent with and have а Council-Manager type of government and also include suggestions to have shared responsibility in terms of hiring and firing of executive positions. The motion carried by the following vote:

Ayes: 3 - Mayor Pro Tem Soria, Councilmember Altamirano, and Councilmember Rebollo

Nayes: 2 - Mayor Argumedo, and Councilmember Mendoza

CITY COUNCIL/SUCCESSOR AGENCY REPORTS

Mendoza reported that he attended South Coast Air Quality Management meeting. Councilmember Mendoza stated that at the meeting he met Julian Castro, Mayor of San Antonio, who is running for the President.

Councilmember Rebollo reported that she attended Community Steering committee meeting at the Senior Center (for AB 617), Royal Breakfast, and Read Across America Event. Councilmember Rebollo congratulated Man of the Year for 2019 and Lety Jaramillo who was selected as Woman of the Year by Assemblywoman Garcia's office.

Mayor Pro Tem Soria reported that he attended Installation Dinner for Industrial Council, Queens Breakfast, attended Gaming Oversight Committee meeting in Sacramento, and gaming workshop in Riverside. Mayor Pro Tem Soria spoke extensively about the issues with gaming that could potentially effect the City.

Mayor Argumedo reported that he was elected as Chairperson of California Cities for Self-Reliance JPA. Mayor Argumedo reported that he attended Industrial Council Installation Dinner, Royal Breakfast, and Library Event "Cat in a Hat".

Councilmember Rebollo stepped out of the Council Chambers at 8:00 pm.
