## RESOLUTION NO. 19-\_\_\_

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA, APPROVING THE MODIFICATION OR REMOVAL OF EXISTING PARKING RESTRICTION SIGNS ALONG 4360 E. WASHINGTON BOULEVARD AND INSTALL RED CURB IN FRONT OF WASHINGTON BOULEVARD NEAR ASH STREET

WHEREAS, business establishments located along Washington Boulevard between Ash Street and Arrowmill Avenue have experienced difficulty in finding adequate parking due to the lack of public parking imposed by the existing parking restriction signs along Washington Boulevard; and

WHEREAS, Public Works staff visited the site and has completed its analysis regarding the parking issues along Washington Boulevard within the vicinity of 4360 E. Washington Boulevard, particularly between Ash Street and Arrowmill Avenue; and

WHEREAS, Staff proposes that the existing parking restriction signs be modified or removed. Currently, the existing four (4) signs prohibit parking between the hours of 7 AM to 9 AM and from 4 PM to 6 PM, Monday through Friday, but this stretch of Washington Boulevard, in the vicinity of 4360 E. Washington Boulevard, is currently wide enough to accommodate both parking and free flow traffic; and

WHEREAS, Staff recommends that the curb be painted red approximately 10-feet in length in front of Washington Boulevard near Ash Street, which is also justifiable, given that there exists a fire hydrant in that vicinity and also traffic mobility will be enhanced; and

WHEREAS, during its regularly scheduled meeting on July 10, 2019, the Traffic Commission recommended the modification or removal of the existing NO PARKING restriction signs along Washington Boulevard from Ash Street to Arrowmill Avenue and to install a 10-foot length red curb in front of the fire hydrant along Washington Boulevard, near Ash Street; and

WHEREAS, per California Vehicle Code Sections 21458 and 21351 and per Commerce Municipal Code Section 10.44.030, the City is authorized to place, maintain, or remove regulatory parking restriction signs and curb markings within the City, and also that the City Council by way of ordinance or resolution, through the authority of the City Administrator / Manager, City Engineer, or the Public Works & Development Services Director, may install or remove parking restriction signs or paint regulatory curb markings.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE DOES HEREBY RESOLVE, DECLARE AND DETERMINE AS FOLLOWS:

<u>Section 1.</u> Per Commerce Municipal Code Section 10.44.030, the City is authorized to place, maintain, or remove signs designating restricted parking and place appropriate colored curb markings, such as red curbs, within the City and also that the City Council by way of ordinance or resolution, through the authority of the City Administrator, City Engineer, and/or the Public Works & Development Services Director, may install, place, or remove appropriate signs and markings.

<u>Section 2.</u> The existing parking restriction signs be modified or removed along Washington Boulevard between Ash Street and Arrowmill Avenue.

**Section 3.** That the curb be painted red approximately 10-feet in length in front of the fire hydrant along Washington Boulevard near Ash Street.
