SUBJECT: Allocate \$160,000 of Measure AA Funds to Fabricate and Install Additional "NO OVERNIGHT PARKING" and "NO VEHICLE DWELLING" Signs along Selected Streets throughout the City

MEETING DATE: September 17, 2019

RECOMMENDATION:

Allocate \$160,000 of Measure AA funds in order to fabricate and install additional "NO OVERNIGHT PARKING" and "NO VEHICLE DWELLING" signs along selected streets throughout the City, as recommended by the Measure AA Advisory Committee.

BACKGROUND & ANALYSIS:

The City Council approved a resolution during its re-scheduled meeting on August 5, 2019 to install "NO OVERNIGHT PARKING" and "NO DWELLING" signs throughout the City in order to reduce the instances of vehicles parking along city streets for an extended period of time, either for habitation or for any other reason (see Attachment 1).

On July 3, 2018, the City Council passed Resolution No. 18-94, approving the proposed "NO OVERNIGHT PARKING" sign installations along several streets in the City of Commerce, in order to eliminate public safety issues due to excessive overnight parking.

Subsequent to the passage of Resolution No. 18-94, City staff installed these signs along the enumerated streets. As a result, many of these vehicles have now migrated to other streets in the City that do not have these signs and are now causing disruptions to nearby businesses and residents. Therefore, Staff identified additional selected streets in the City of Commerce experiencing an increased number of vehicles parking for an excessive period of time, and thereby creating additional public safety and public nuisance concerns.

The "NO OVERNIGHT PARKING" signs will be placed above the "NO DWELLING" signs (see Attachment 2). The additional amount for these extra signs is \$160,000, including material, parts, labor for installation, and also for contingencies.

During its regularly scheduled meeting on Tuesday, September 10, 2019, the Measure AA Advisory Committee unanimously recommended and approved the allocation of \$160,000 of Measure AA funds for the fabrication and installation of the additional "NO OVERNIGHT PARKING" and "NO DWELLING" signs.

FISCAL IMPACT:

The allocation of \$160,000 will be added to project account no. 43-5170-52001.14648 in order to defray the costs of fabricating and installing the additionally requested "NO OVERNIGHT PARKING" and "NO DWELLING" signs.
