SUBJECT: Approve Temporary Street Closures for the City of Commerce's

2019 "Trick or Trot" 5K Run

MEETING DATE: October 15, 2019

RECOMMENDATION:

Adopt resolution authorizing temporary street closures for the City of Commerce's 2019 "Trick or Trot" 5K run to be held on Saturday, October 26, 2019.

BACKGROUND:

Previously, every year around Thanksgiving in November, the City hosted the annual "Turkey Trot" 5K run. The Turkey Trot was re-scheduled and renamed as the "Trick or Trot" 5K run in 2018 and it is now held in October, near Halloween. Trick or Trot will have a Halloween theme, with appropriate treats and prizes.

This event is held during morning hours and is open to people of all ages who wish to participate. The route for this run is within the Rosewood Park neighborhood area, and for this year, the Trick or Trot will be held on Saturday, October 26, 2019.

In order to ensure a safe and worthwhile event, Public Works staff enlisted the services of Elie Farah, Inc. (EFI), one of the City's on-call traffic engineering consultants, to provide a traffic control plan. The traffic control plan shows all the traffic control devices needed to provide adequate traffic safety for the event. In addition, the traffic control plan requires the closure of certain streets in order to be effective. The preparation of a traffic control plan is a "Best Management Practice" consistent with the City's risk management for the Trick or Trot.

ANALYSIS:

California Vehicle Code Section 21101, Subdivision (e), provides that local authorities may, by ordinance or resolution, temporarily close a portion of any street under their

jurisdiction for "celebrations, parades, local special events, and other purposes" when necessary for the safety and protection of persons who are to use that portion of the street during the temporary closing.

For the Trick or Trot on Saturday, October 26, 2019, the proposed temporary street closures will be from 5:00 A.M. to 11:00 A.M. on the following streets:

- Eastern Avenue (one lane northbound from Harbor Street to Jillson Street)
- Commerce Way (between Harbor Street and Jillson Street)
- Jillson Street (between Eastern Avenue and Boris Avenue)
- Harbor Street (between Commerce Way and Eastern Avenue)
- Rosewood Area (Bartmus Street, Jardine Street, Leo Avenue, and Boris Avenue)
- The Village (Entrada Street, Mission Way, Fairgrounds Street, Village Drive, and Plaza Street)

A copy of the traffic control plan that delineates the road closures for the event route is attached. *Please see Attachment.*

Staff recommends that City Council authorize the temporary street closures for the 2019 Trick or Trot. Upon approval, Staff will provide notices to all residents affected by the temporary street closures and will post "no-parking" signs as appropriate.

FISCAL IMPACT:

An annual cost of approximately \$800 for the rental of the required traffic control devices will be absorbed by the 2019/2020 fiscal year budget. This will be an annual recurring cost and will have to be considered during future year budgets to accommodate subsequent events.
