**IRREVOCABLE RIGHT-OF-WAY EASEMENT
CITY OF COMMERCE, STATE OF CALIFORNIA**

NP 6800 Washington, LLC, a California limited liability company ("**Grantor**") hereby grants to the **City of Commerce**, a California municipal corporation ("**Grantee**"), for public street and incidental purposes, including but not limited to sidewalk, public utilities, landscape, maintenance, and vehicular and pedestrian access purposes, an irrevocable right-of-way easement in, over, under, upon, and across all that real property situated in the City of Commerce, State of California, and described in Exhibit "A" attached hereto and incorporated herein (the "**Right-of-Way Easement**"). The Right-of-Way Easement is depicted in the diagram marked as Exhibit "B", which is attached hereto for clarity only.

Owner represents and warrants that Owner owns the real property described in Exhibit "A", and that there are no encumbrances on such real property that would prohibit or interfere with this Right-of-Way Easement and the rights granted to Grantee pursuant to this deed, and that there are no monetary liens (except for property taxes and assessments not yet delinquent) affecting such real property.

The Grantor agrees for itself, and its successors and assigns, not to construct, erect, place or maintain, nor to permit the construction, erection, placement or maintenance, of any permanent or temporary building, improvement, or structure upon the Right-of-Way Easement without the advance written agreement of the Grantee.

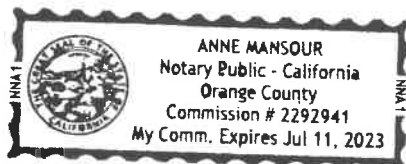
