#### INVOCATION

Mayor Soria offered the invocation.

#### **PUBLIC COMMENT**

Brian Medina, representative of non-profit Tree People, invited residents to a community meeting scheduled for November 14, 2019, at the Commerce Senior Center regarding the location of trees to be planted in Commerce.

Gloria Nezahualcoya spoke for the record.

Sharon Basic complimented CSO Sanchez for assisting in crowd control during Halloween. Ms. Basic asked whether the City could paint crosswalks before holidays.

#### **CONSENT CALENDAR**

Councilmember Mendoza asked to pull item #3 for discussion.

Administrative Service Director & City Clerk Shumway provided a brief overview of the staff report. Councilmember Mendoza asked what the criteria for submitting photographs are. and Director Shumway explained that it could community/building photos or events, but something that is featuring the community either architecture, art in public place, or City events/sports. Following additional discussion, it has been decided to increase the budget to \$1,000 but also increase the number of first, second, and third place winners. It was recommended to establish first place at \$200-300, second place \$100 and third place \$50.

Mayor Soria moved, seconded by Councilmember Rebollo, to authorize staff to initiate the City of Commerce Photo Contest, increase budget to \$1,000, and increase number of first, second and third place winners, and approve rules and guidelines for the Contest. The motion carried by the following vote:

7. Resolution Opting for the City of Commerce to be Included in a

Prospective 2020 Revenue Measure to Fund Critical Fire Protection and

Emergency Services

Finance Director Domic provided an overview of the staff report.

Discussion took place about what cities opted in, and whether the City would have to cover upgrades in a future and fund it. It was stated that all funds collected within jurisdiction would be spent in the City, and every three years the city could meet with the Fire District and negotiated the allocation percentages.

Councilmember Mendoza moved. seconded by Councilmember Argumedo, to adopt Resolution opting for the City of Commerce to be included in a 2020 revenue fund critical fire prospective measure to protection emergency services should the Consolidated Fire Protection District of Los Angeles County and the Los Angeles County Board of Supervisors decide to pursue such a Measure. The motion carried by the following vote:

## 8. <u>Presentation Regarding User Fees and Development Impact Fees</u>

Councilmember Rebollo moved, seconded by Councilmember Argumedo, to continue this item to the next regular scheduled meeting. The motion carried by the following vote:

9. <u>City of Commerce Water System Presentation Regarding Proposed Water</u>
<u>Rates and Evaluation of Financial Position of Water System</u>

Deputy Director of Operations Nila provided an overview of the staff report.

Discussion took place regarding the capacity of the existing pumps, water rights, and aging infrastructure. Councilmember Argumedo and Mendoza stated that they favor keeping the system and keeping control of the water rights.

In response to Councilmember Rebollo's question of whether the water rates could be capped in case the water system is sold to a private party, Deputy Director Nila stated that staff could review and possibly include it as part of sale agreement. Further discussion took place of the emergency and the City's intent to interconnect wit Calwater system. The City is also generating about \$500,000 for the leased water rights.

According to Finance Director Domic, Enterprise Funds typically subsidize the General Fund, but currently it is the other way around. All Capital Improvements and repairs are not covered by the revenue brought in.

No action was taken on this item, and it was a presentation only.

## 10. Report and Update on Preparations for Citadel Black Friday Event

Director of Public Works and Community Development Hernandez provided an overview of the staff report.

Extensive discussion took place that while Citadel Outlets representatives and City staff address the traffic at Citadel, residential neighborhoods that are in the area and resident concerns are not addressed. Recommendation was made that outside traffic control company is hired to direct traffic away from residential streets. Discussion took place about fire emergency lane, and it was stated that staff should prepare ahead of time, to get a consensus of all the parties involved. Further discussion took place on parking and controlling traffic from residential streets. Mayor Soria asked for 9 months, 6 months, and 3 months briefing and discuss potential solutions and analyze.

### CITY COUNCIL/SUCCESSOR AGENCY REPORTS

Councilmember Argumedo reported that he attended volleyball game at Veteran's park, annual Halloween Parade in Rosewood park, and wished his Commissioner Zavala Happy Birthday.

Councilmember Rebollo reported that she attended Halloween Parade, Dia de los Muertos celebration, Trick or Trot, also Dia de los Muertos polo tournament at Aquatics Center, and Food Truck Movie Night. Councilmember Rebollo asked that the Council and staff think about establishing a skate park in Commerce.

Councilmember Mendoza reported that he toured the Transportation Department, and Libraries, attended CERT training, Halloween Parade, volleyball game, and pancake breakfast at Lions Club. Councilmember Mendoza asked that dip on ramp from I-710 to Washington Boulevard is fixed.

Mayor Soria reported that he was part of the delegation at Aguascalientes, Mexico, and attended Truck or Treat at Bandini Elementary.
