Ofelia Avila spoke in opposition to the current Councilmembers and cannabis in the City of Commerce.

Carlos Rosales spoke in opposition to cannabis.

Alma Suarez campaigned for March 3, 2020 election and spoke in opposition to the cannabis business.

Elisa Padilla spoke in support of Candidate Rebollo.

Richard Hernandez spoke about lies by Councilmembers.

Gloria Nezahualcoya spoke in opposition of cannabis, and corruption.

Steve Viesca stated that Council bringing new businesses to the City and spoke in support of cannabis that brings jobs and revenue for the City.

Lora Logan, President of Employee Association, stated that the association unanimously endorsed one candidate Oralia Rebollo for March 3, 2020, election.
