### CALL TO ORDER

Mayor Altamirano called regular City Council meeting to order at 6:07 p.m.

### ROLL CALL

Councilmember Soria joined the meeting at 6:34 p.m.

#### PUBLIC COMMENT

Transportation Director McFerguson spoke about transit plan called "Commerce in Motion" and invited everyone to participate in a virtual open house on Wednesday, June 17, 2020, at 6:30 p.m.

Director of Administrative Services & City Clerk Shumway read a comment submitted by Matthew Buck, Vice President of Public Affairs of California Apartment Association, in opposition of item #11 regarding changes to AB 1482.

### **CONSENT CALENDAR**

Mayor Pro Tem Rebollo asked to pull item #9.

Mayor Pro Tem Rebollo asked about concerns about indemnification in the Memorandum of Understanding language. City Manager Cisneros stated that the legal counsel advised for a stronger language in the indemnification clause; however, County responded that this is the common language used for other MOUs and standard language used for all cities. According to Assistant City Attorney Copado, if the company performing services does not deliver correctly, the City shall be responsible, and there is no mutual covenant provision included. It was stated that the residents would benefit from clean-up, and that outweighs the potential liability. The MOU was already approved by the other cities, and the County wants to keep it uniform for all cities.

City Manager Cisneros added that the agreement is not with DTSC, but with the

Los Angeles County Development Authority for paint hazards clean-up. It was requested that staff provides a list of cities that already approved MOU, and see if the County would recom=nsider changing the language. The City Council tabled this item to a later date.

### SCHEDULED MATTERS

10. Consideration of Resolutions Authorizing Calling a Special Municipal Election to Place a Measure on the Ballot, and Consolidating Same with the November 3, 2020 Election, to Submit to the Voters and Ordinance Amending Ordinance No. 634 to Amend Section 2.08.160 of Chapter 2.08, of Title 1, of the Commerce Municipal Code, Regarding Term Limitations

Director of Administrative Services and City Clerk Shumway provided an overview of the staff report.

Councilmember Mendoza was concerned with the increased term limit yime for current Councilmembers ranging from nine months to two years, and the cost of the election. Further discussion took place regarding State Law that required consolidation with the County election, which added nine months to the current terms, and discussion regarding unexpired term and how it affects the term limits and creates inconsistency. It was a consensus among the City Council to table this item to a later date.

### ORDINANCES

 Urgency Ordinance and Regular Ordinance Adding Chapter 9.95 to Commerce Municipal Code Adopting and Expanding the Tenant Protection Act of 2019 Relating to the Prohibition of No-Fault Terminations of Tenancy and Evictions and Limiting Rent Increases for Residential Real Property.

Assistant City Attorney Copado provided an overview of the staff report. Discussion took place regarding the proposed ordinance and the enforcement. It is a complaint based ordinance. Assistant City Attorney stated the information would be posted on the City's website, and any violations would be treated as the code enforcement cases. Administratively staff could issue citations with the threat of the fine and go to formal prosecution. According to the Assistant City Attorney Copado, staff would issues a notice of violation first and give the opportunity to comply before the City imposes any violation.

*Further discussion took place regarding rent increases and compliance with AB 1452.* 

Councilmember Mendoza moved, seconded by Councilmember Argumedo, to read

the ordinance by title only and approve for first reading and Ordinance adopting and expanding the Tenant Protection Act of 2019 relating to the prohibition of no-fault terminations of tenancy and evictions and limiting rent increases for residential real property. The motion carried by the following vote:

Councilmember Mendoza moved, seconded by Councilmember Argumedo, adopt Urgency Ordinance adding Chapter 9.95 to the Commerce to an Municipal Code relating to just cause termination of tenancies, rent control, and declaring the urgency thereof. Director of Administrative Service and City Clerk read the title of an Ordinance. The motion carried the bv following vote:

Director of Administrative Services and City Clerk Shumway provided a brief overview of the staff report.

Councilmember Mendoza moved, seconded by Councilmember Argumedo, adopt Ordinance amending Sections 10.44.130 AND 10.44.140 OF Chapter to adding Sections 10.44.135 AND 10.44 ("Stopping, standing and parking) and 10.44 ("Stopping, 10.44.136 to Chapter standing and parking") to the Commerce Municipal Code, creating а Temporary Recreational Parking Vehicle Disability Program and Recreational Parking Permit а program. Director of Administrative Services and City Clerk read the title of an Ordinance. The motion carried by the following vote:
