SUBJECT: Authorize Donation of Two (2) Surplus Over-the-Road Diesel MCI

Buses to Secondary School No. 110 "Nuevo Patzzcuaro," located in

Mexicali B.C.

RECOMMENDATION:

At the request of the State Educational System, Department of Middle Education, the City Council will consider the donation of two (2) surplus Over-the-Road Diesel MCI Buses to Secondary School No. 110 "Nuevo Patzcuaro," located in Mexicali B.C.

BACKGROUND:

The two (2) diesel MCI buses (Units 307 & 308) being recommended for donation no longer meet current emissions regulations and have exceeded their useful life for the City's purposes and standards.

Based on the Federal Transit Administration vehicle replacement guidelines, the useful life period for an over-the-road diesel MCI bus is twelve (12) years. Additionally, per the California Air Resources Board, all heavy diesel vehicles (Gross Vehicle Weight Rating greater than 26,000 lbs.) with 1996 or older engines must comply with 2010 emissions. Based on the above mandate, vehicle numbers 307 & 308 no longer meet compliance and are no longer legal to operate in California.

ANALYSIS:

The vehicles referenced above are no longer legal to operate in California, and no longer cost-effective for the City to maintain or store at the Transportation Yard which is already at capacity.

Further, the donation of two (2) buses to Secondary School No. 110 "Nuevo Patzcuaro," serves a public purpose and a public benefit as the school intends to use the buses to provide its students with a means of transportation to get to and from school. Further, having a means of transportation for its students opens opportunities for them to participate in extracurricular athletic and academic activities that require travel to other regions. The donation of said buses is consistent with the City's commitment to civic engagement and its guiding principles of supporting and creating partnerships with educational institutions and organizations in order to make education and recreational opportunities accessible to all children and youth.

FISCAL IMPACT:

This item has no impact on the City's current operating budget. Donating the surplus diesel buses will potentially result in a loss of approximately \$10,000 in revenue from the selling the buses via auction.
