1. Presentation/Update from the Sheriff's Department Regarding Public Safety in the City of Commerce

*Captain Mejia provided a crime statistics report and response time. According to Captain Mejia, response time for routine calls is 60 minutes, and the East Los Angeles station response time is 27 minutes for routine calls. For priority calls, response time is 27 minutes, and the East Los Angeles Station Deputies response time is 6.3 minutes, and for emergency calls - 10 minutes and 8 minutes, respectively.*

*As for burglaries, Deputies were pleased to report that on August 25, 2020, at 4 p.m. the suspects were arrested for catalytic converters theft. As for the street racing problem, Sheriff's are working together with CHP, and COPS team received specialized training. It is an on-going on meeting with constituents and providing tips on how to reduce or report the crime.*
