# APPEARANCES AND PRESENTATIONS

1. <u>Presentation/Update from the Sheriff's Department Regarding Public Safety in the City of Commerce</u>

Sergeant Villareal provided an update regarding the arrests and the shooting incident on Washington and Commerce Way. This matter is under investigation. There were a couple of shootings in Commerce on October 4, 2020, at the block of

Eastern and Triggs as well.

Sergeant Villareal Introduced new Lieutenant Eric Barron, who is replacing Lieutenant Chadwick.

Mayor Pro Tem Rebollo asked for the update on cameras and when they are going to be installed.

### **PUBLIC COMMENT**

Director of Administrative Services and City Clerk Shumway read the following public comments for the record:

Adrian Garcia, Government Relations Manager for Southern California Edison, opposed Balanced Energy Resolution (item #13).

Jessica Staine, Fermin, Mariella Padilla, and Mandi Marquez - Roach urged the City Council to support getting the sports programs back in session, at least outdoor practices.

Leonel Resado, volunteer coach for Commerce Hearts Traveling Soccer Team, urged to reopen the sports programs while following Covid -19 guidelines.

Dina Coronado, Vice President of Building Industry Association of Southern California, Inc., issued a support letter for balanced energy solutions (item #13.)

David Juarez, Director of Local Government Affairs for California Restaurant Association, issued a statement supporting Balanced Energy Solutions and maintaining local control of energy solutions.

Bruan Medina updated the City Council and the community about upcoming TreePeople events and initiatives.

Team Ozeqbe issued a statement opposing State Measure 16.

Johncito Peraza thanked City Manager Cisneros, CSOs, and Code Enforcement for working on the incident that occurred in Rosini Neighborhood. Mr. Peraza asked that the annual holiday craft fair is held this year and supporting the installation of additional speed humps.

### **CONSENT CALENDAR**

Item #13 - City Manager Cisneros provided a brief overview of the staff report. Denise Campos, Public Affairs Manager for SoCalGas, agreed that the energy source should be reliable, affordable, and balanced for the City. According to Ms. Campos, SoCalGas supports renewable energy. The goal is to become the cleanest renewable energy, and passing this policy is for affordability and choice control for businesses and residents.

Adrian Garcia, Southern California Edison, opposed the resolution and noted that it supports specifically natural gas. Mr. Garcia talked about supporting the electric option to reduce green gas emissions and moving toward cleaner California.

Discussion took place. It was a consensus among the City Council that this is a very good policy that will benefit residents and businesses.

Councilmember Soria moved, seconded by Councilmember Argumedo, to adopt resolution supporting Balanced Energy Solutions and maintaining local control of energy solutions. The motion carried by the following vote:

# 14. Report and Update on Preparations for Citadel Black Friday Event

Director of Public Works Hernandez provided an overview of the staff report regarding current preparations for the Black Friday event at Citadel.

Mayor Pro Tem Rebollo inquired whether a traffic control company could be brought in to direct traffic on the congested streets and some closed streets. It was suggested to look into contracting out with the White Glove company. In addition, it was recommended to ticket people for blocking intersections. Director Hernandez stated that staff could look into increasing signage to prevent blocking of the intersections stating that violators will be cited. Sergeant Villareal added that ticketing during that congested traffic would create more problems by blocking a lane.

Further discussion took place about providing more shuttles to Citadel. In addition, it was recommended to install a RedFlex camera at Steven's Steakhouse intersection in order to prevent blocking of the intersection and direct traffic at Mixmaster.

In response to Councilmember Soria question regarding the protocols for safety and precautions during Covid, Mr. Nelson Kafieh, Loss Control Manager, stated that security is trained in warning people about necessary precautions and will be providing masks if needed. However, store managers and personnel were instructed on zoom calls that the amount of customers has to be controlled, enforce social distancing, and face-covering for customers inside the stores. There is also signage available. This year security was increased to 100 personnel, and the number of deputies was increased to 20, accordingly.

Councilmember Mendoza recommended closure of the residential streets to prevent parking and driving through neighborhoods and maybe have two ways in and out.

15. <u>Presentation by Community Advanced Development Corporation</u>

<u>Regarding their Proposal for City-Owned Properties Located at Gage and Zindell</u>

Amanda Gatternby and Chris Kolbenschlag provided a presentation regarding the Community Advanced Development Corporation proposal to develop four parcels 7169,7165,7155 and East Gage Avenue.

Discussion took place regarding the length of the project and affordable housing and rents. Rents depending on income, will be ranging from \$1,056 to \$2,028. Twenty-two units will have reduced rent to 30% cost of those units. Mayor Altamirano inquired whether mixed-used could be possible for this project.

Further discussion took place about affordable housing. Chris Baker stated that affordable units are all units low income (45) and 22 units would be eligible and paying only 30% of their income for rent.

This was informational item only. No action was taken on this item.

Assistant City Manager Domic provided a presentation regarding operating budget for fiscal year 20-21.

Discussion took place regarding the shortfall and how much casino revenue is coming at this point, and anticipated.

Councilmember Mendoza moved, seconded by Councilmember Argumedo, to approve Resolution adopting the annual operating budget for fiscal year 2020-2021. The motion carried by the following vote:
