14. <u>Award of Contract to Polychrome Construction, Inc for Citywide Bus Shelter</u> Beautification Project

Mayor Altamirano left Council Chambers at 7:36pm.

Public Works and Development Services Director Babaki provided an overview of the staff report.

Discussion took place regarding bus shelters at Bandini area that are painted brown color while the City bus shelters are green and whether they could be painted green. Transportation Director McFerguson stated that those bus benches belong to the City of Bell.

Councilmember Councilmember Leon moved, seconded by Argumedo, to adopt Resolution approving a construction contract for Citywide Bus Shelter **Beautification** Project Polychrome authorizing to Construction, Inc. and Transtech Engineers, to with construction management, Inc. proceed construction inspection and project management services. The motion carried by the following vote:

Finance Director Domic provided an overview of the staff report.

Councilmember Rebollo moved. seconded by Councilmember Argumedo, to adopt Resolution Professional Services Agreement with approving Vision City Commerce redesign. implementation, Internet for the of migration. maintenance and support of the City website. The motion carried by the following vote:

16. Proposed Ferguson Drive Railroad Sound Wall Project

City Administrator Rifa provided an overview of the staff report, and stated that the Council has the option of allocating funds for study and design of the sound wall to initiate the process. The length is estimated at 2,500 and the cost of the project is approximately is 1.2 million dollars. According to Councilmember Leon, the City should continue negotiations with the Union Pacific, and they should be held responsible for the construction of the wall. Discussion ensued. Councilmember Argumedo recommended not to wait and initiate a process.

City Administrator Rifa clarified that there is no provision in the agreement the Union Pacific would pay for the entire wall. Councilmember Rebollo stated that there was an agreement signed 12 years ago. Further discussion took place. It was decided that since this is a CIP project, it needs to be reviewed and prioritized like all other City project. Director Babaki stated that the funding for design of sound wall will be brought up at tomorrow's meeting of December 7, 2016.

Councilmember Argumedo stated that in the past he was involved in some discussion after the derailment, and the Union Pacific did not want to pay for the wall. The City negotiated as much as they could at that time. No action was taken on this item. It was informational only.

17. Addition of Two (2) Community Services Assistant Posts

Director of Community Services and Public Safety Department Rodriguez provided an overview of the staff report. Councilmember Rebollo thanked for bringing this item forward. Discussion ensued.

Councilmember Rebollo moved, seconded by Councilmember Argumedo, to approve the addition of two Community Services Assistant Posts to be located at Bandini Elementary School and at Rosewood Elementary School. The motion carried by the following vote:

Director of Community Services and Public Safety Rodriguez provided a brief

overview of the staff report.

Councilmember Argumedo moved, seconded by Councilmember Rebollo, to approve Resolution rescinding an Agreement with Rio Hondo Community College District approved at the Council meeting on September 6, 2016, and approve a corrected agreement with Rio Hondo Community College District to provide training for the City of Commerce Urban Search and Rescue Team. The motion carried by the following vote:

City Administrator Rifa provided an overview of the staff report and stated that out of 10 cities surveyed City Council does not direct the Mayor on how to vote. Discussion ensued. All Councilmembers recommended that the vote is cast for Diane Dubois as the best candidate representing the City and being very knowledgeable. There were no action taken on this item, it was informational only.

CITY COUNCIL/SUCCESSOR AGENCY REPORTS

Councilmember Argumedo reported that he attended Neighborhood Watch meeting and Children's library holiday program. Councilmember Argumedo stated that security cameras program is received well by the community.

All Councilmembers complimented staff on great Tree Lightening event.

Councilmember Rebollo reported that she attended East LA parade and Water Coalition meeting. Councilmember Rebollo invited all residents to Unplugged performance at the Teen Center.

Councilmember Leon invited youth to apply for youth commission vacancy.

Mayor Pro Tem Baca Del Rio stated that the Library Youth event was a great event, and announced that the Snow Day is scheduled for December 17, 2016 in Veterans' park at 10:00 p.m. Mayor Pro Tem asked to provide a report on removal of trees in Bandini area and what trees would replace the ones removed.

Councilmember Leon requested a follow-up report by City Administrator on the public comments during the City Council.
