Frank Morales asked for Council support. Mr. Morales stated that he is planning to run for the office with the Montebello Unified School District.

Jorge Salas Ortiz, teacher at Rosewood Park School and City's Parks and Recreation employee, and President and Vice president of the Renaissance Club, spoke about the Renaissance Club purpose, activities and asked for the Council support.

Maryam Babaki, Director of Public Works and Development Services, announced that the City received an award for Green Zones Plan the LA Region American Planning Association.

# **13.** <u>Astor Avenue Median Island Beautification and Speed Hump Installation</u> Funding Requests

Director of Public Works and Development Services Babaki provided an overview of the staff report. According to Director Babaki, Measure AA Advisory Committee recommended to proceed with the project. Discussion took place regarding drainage issues and residential parking being reduced to the proposed layout of the medium, and different options were discussed.

Discussion continued regarding the loss of parking and that the community should decide pros and cons of that concept including beautification of the area prior to finalizing the concept.

Discussion ensued about the speed humps policy and it was recommended that the residents in that area are made aware of the policy and know that they need to file a petition in order to implement speed humps. Councilmember Rebollo asked that staff promotes information about the speed hump policy at all local clubs.

Mayor Pro Tem Baca Del Rio moved, seconded by Councilmember Argumedo, to approve funding and bring options for parking matters and beautification related to the Astor Avenue Median Island Beautification and Speed Hump Installation. The motion carried by the following vote:

14. <u>Renaissance Club at Rosewood Park School Leadership Camp</u> Sponsorship Consideration

Deputy Director of Parks and Recreation Department Marquez provided an overview of the staff report.

Councilmember Rebollo stated that she fully supports this request. Discussion took place regarding lack of opportunities for the children, and directed staff to find out what the School District is doing to increase leadership and opportunities for Commerce youth and see if there are any future collaboration between the City and School district to develop better opportunities for the youth.

Interim City Administrator Rodriguez stated that the City would provide City bus for transporting Renaissance Club members to Camp Commerce. Councilmember Leon asked that staff invited Montebello Unified School District to discuss increasing opportunities for children, and also fix problems with the auditorium. And how they are going to upgrade that school to accommodate 1,100 students.

Mayor Pro Tem Baca Del Rio requested future agenda item to re-establish cultural excursions for the school programs that they had before and it was dissolved during the recession.

Councilmember Rebollo moved, seconded by Mayor Pro Tem Baca Del Rio, Option 1 and full requested sponsorship approve approve for the to Renaissance Club at Rosewood Park School to an 8th grade Leadership Camp to be held at Camp Commerce June 7-9, 2017. The motion carried by the following vote:
