Councilmember Soria asked that Fleet Maintenance Supervisor job description is made more detailed. SCHEDULED MATTERS

7. <u>California High Speed Rail Los Angeles to Anaheim Project Section and</u> Impacts to the City of Commerce

Public Works and Development Services Director Babaki provided a brief introduction and overview of the previous actions in regard to this matter.

Michelle Vons, Representing Metro, stated that the residential impacts were eliminated, and 2.54 miles of the High Speed Rail were reduced to 1.4 miles and number of effected businesses in Commerce were reduced in half. According to Ms. Vons, they are completing the planning documents, working on alternatives, and conducting community outreach. Discussion took place regarding the possibility of scheduling community meeting in Commerce in order to let residents know about potential impacts.

Further discussion took place whether there would be any noise issues, to which Ms. Vons responded that in residential areas the trains would be going at a reduced speed. According to Ms. Vons, electric trains are not going to increase noise, but other trains utilizing rail potentially could. There will be fencing installed, and also noise study will be conducted. Further discussion took place regarding funding for the entire project.

Councilmember Mendoza stated that there are impacts coming from different areas and the City of Commerce becoming a transportation hub, which is an issue for the residents. If this is a case, this development should benefit the community.

City Attorney Olivoasked whether other cities have similar impacts and whether effected businesses located on Washington had been made aware of the potential impacts. Ms. Vons responded that the City of Commerce has larger impacts cause the length of the rail is twice as much than other cities. Santa Fe Spring is another city that is affected the most.

Further discussion took place regarding potentil impact and the City loosing revenue by relocating businesses.

Mayor Pro Tem Altamirano moved, seconded by Councilmember Argumedo, to receive and file presentation regarding California High Speed Rail Los Angeles to Anaheim Project section and impact. The motion carried by the following vote:
