### **PUBLIC HEARINGS**

Conditional Use Permit No. 520 6555 East Gage Avenue A request to allow the expansion of an existing cemetery land use to include the construction of a two-story mausoleum with a footprint of 24,500 square feet within the City's CPF (Commercial Public Facility) zoning district. Per Chapter 19.13.020 of the Zoning Code, a CUP is required to expand an existing cemetery land use in the CPF Zoning District.

City Planner Jimenez presented the staff report and informed the Commission that staff's recommendation was to approve the Conditional Use Permit.

Deputy Director of Development Services/Liaison Marquez presented this item regarding Customer Service and the Business License process to the Commission.
