Public Works and Development Services Director Babaki provided an overview of the staff report. Archy Davenport, Kosmon & Associates, spoke about the potential development and evaluating hotels and retail options for the site.

Councilmember Mendoza stated that there is no supermarket in the community, and lack of night life opportunities that could be looked into. Discussion took place on what kind of hotels are recommended for the area, and Mr. Devenport stated that they are looking into national upper to middle scale hotels. discussion took place on potential mixed use for the development. Councilmember Argumedo recommended keeping options open and look at what projects that would be more viable and beneficial for the City. Mr. Devenport stated that Kosmont is evaluating hotel and retail options, but at the same time performing other analysis for the potential uses.
