## 9. Preserving Local History Project Status Update

Library Director Sarmiento provided an overview of the Senior staff report. Librarian Sonia Batista spoke about preservation of the existing photos, publications, and what equipment would be required. Discussion took place on the cost of the necessary equipment for document preservation. No action was taken on this item

# 10. Update on Pilot Program Temporary Closure on Fitzgerald Avenue

Isaes Cantu, Commerce resident, stated that he would like to conduct survey and count cars that are parked on the street. Mr. Cantu spoke in support of the permit parking.

Priscilla Perez, Richard Homeswter and Evelyn Serfozo all spoke in support of the permit parking.

Ernesto Gonzales, opposed permit parking.

Public Works and Development Services Director Babaki provided an overview of the staff report. Discussion ensued about the fence being installed. Councilmember Hugo who is the member of the Fitzgerald Matters subcommittee stated that there is some opposition to closing a street, and it was decided to install temporary wall as a pilot program to see if that works and residents prefer that solution. Further discussion took place regarding installing temporary fence and whether residents should be voting on this matter before any decision is made by the City Council.

Mayor Pro Tem Altamirano moved, seconded by Councilmember Argumedo, to approve the pilot program for temporary street closure on Fitzgerald Avenue, and installation of the temporary wall. The motion carried by the following vote:

# 11. Report on Recovered Costs by Public Works and Development Services Department for 2017-2018

Public Works and Development Services Director Babaki provided an overview of the staff report. No action was taken on this item. It was informational only.

## **12.** Request for CPI Rate Increase from Nationwide Environmental Services

Deputy Director of Public Works Operations Nila provided an overview of the staff report.

Councilmembers Mendoza and Argumedo opposed the automatic 4% increase provision in the proposed contract. It was stated that Nationwide provides excellent quality service, however, it was a consensus among the City Council to eliminate automatic yearly increase. It was recommended that the increase is brought up to Council for discussion on a yearly basis.

Councilmember Soria moved, seconded by Mayor Pro Tem Altamirano, to modifications Agreement with **Nationwide Environmental** approve to Services, a Division of Joe's Sweeping Inc (Nationwide) for catch basin and street sweeping services to allot for а rate increase. excluding requested automatic 4% CPI request. The motion carried by the following vote:

## 13. Revisions to the Personnel Classification and Compensation Plan

Interim Human Resources Director Beas provided an overview of the staff report. Discussion took place about fairness and not tailoring positions to the existing staff members and not raising or lowering requirements for some positions. It was a consensus that positions across the board should be treated fairly.

Councilmember Mendoza recommended to wait for class and compensation study before making any decisions on the positions. Councilmember Argumedo stated that everyone have to be provided an opportunity, the City has to be consistent and everyone who meets criteria has an opportunity. Further discussion ensued.

Interim Human Resources Director Beas stated that some positions are vacant and the decision needs to be made now, so they could advertise for positions.

It was a consensus among the City Council not to change any requirements for Camp Manager positions, instead of part-time dispatcher have full-time dispatcher, increase educational requirements for HR Analyst I and II positions and increase step from 23 to 26 and 28 respectively, approve revisions to Accountant, and Library Supervisor positions. Fleet mechanic position was tabled.

Councilmember Argumedo moved, seconded by Councilmember Soria, Resolution approving to the Personnel Classification and revisions Compensation Plan for certain positions in Transportation, **Parks** & Recreation, Human Resources and Library, not change Supervisor requirements, table mechanic position and increase position of Dispatcher from part-time to full-time. The motion carried by the following vote:
