PUBLIC HEARINGS

Conditional Use Permit No. 513 6340 Washington Boulevard

A request to allow the expansion and improvements to an existing unmanned fueling facility by adding a third fueling position per lane and to allow the sale and dispensing of diesel sales in conjunction with existing regular fueling sales at the Costco Business Center, located at 6340 Washington Boulevard, which is located within the City's C-2 zoning district. A CUP is required in order to expand a fueling facility (gasoline station) in the City's C-2 zone.

Conditional Use Permit No. 524 Right of way adjacent to 5675 Telegraph Road A request to allow the removal of an existing 29 foot high Southern California Edison (SCE) light pole and replace it with a new pole of a slightly larger diameter that will be topped with a new Small Cellular Antenna with backhaul equipment at an approximate height of 32'4". Per Section 19.27.030 of the zoning code, building or ground-mounted cellular, personal communications service ("pcs"), or other wireless antenna shall be considered a public utility use subject to the conditional use permit process.

A request to amend Table 19.21.040A (Off-Street Parking Requirements) of Chapter 19.21 (Off-Street Parking and Loading) of the Commerce Municipal Code to address the required number of parking spaces for convenience stores as well as to clarify that truck parking spaces are required when proposing loading bays.
