22. <u>Senior Rent Subsidy Program Reactivation</u>

Mayor Rebollo stated that the Council received complaints and heard the issues that seniors have to deal with, and looked for the way to assist seniors. Mayor Rebollo recommended to increase subsidy to \$250. Discussion took place regarding the guidelines and City Administrator Cisneros stated that the guidelines were modified from the previous program that was in place. Further discussion ensued. City Administrator recommended based on the discussion to allocate additional \$5,000 to help out those applicants that do not qualify but on emergency basis and develop guidelines for those types of cases.

Mayor Rebollo moved, seconded by Mayor Pro Tem Altamirano, to direct staff to initiate the Senior Rent Subsidy Program and move subsidy to the amount of \$250, direct staff to update all necessary program policies and procedures and allocate additional \$5,000 for emergency cases/one time based. The motion carried by the following vote:
