# 14. <u>Release of Request for Proposals for Police Services Alternatives</u> <u>Analysis</u>

City Administrator Cisneros provided an overview of the staff report. Discussion took place on what staff members should be on the selection panel. City Administrator Cisneros provided an overview of the RFP process, and that the City Council would ultimately be selecting the firm to conduct policing study, following staff review of qualifications, RFPs and other requirements.

**City Council** 

Councilmember Argumedo stated that in the past when the City was looking in contracting Fire Department, LAFCO had the final say in that and asked that staff double check whether they would be involved in the process. Discussion took place whether there is a need to look into other services, or maybe enforce existing contract. Further discussion took place regarding customer service provided by the LA County Sheriff and resident complaints received. Councilmember Argumedo recommended potentially looking into creating a subcommittee to review existing contract and come up with the recommendations reaardina improving the services provided by Sheriff's Department.

It was a consensus among the City Council to table this item to a later date pending verification of questions regarding LAFCO concerns.

# **15.** <u>Utility Box Art Beautification Program Artwork and Location Selection</u> -Phase <u>2</u>

Public Works and Development Services Director Babaki provided an overview of the staff report. Discussion ensued.

# 16. <u>Tree Maintenance on Private Property in the Village Residential Community</u>

City Administrator Cisneros provided an overview of the staff report. It was staff's recommendation to uphold the 2013 policy. Discussion took place whether the City would allow one more time to trim trees on the private property. Following discussion, it was a consensus among the City Council to uphold the 2013 policy decision pending that staff provides proof that residents were contacted regarding City's offer to trim their Ficus trees, and every effort was made to reach out to them.

Councilmember Argumedo moved. seconded by Councilmember Mendoza, to approve staff's recommendation regarding discontinuance of tree maintenance on private property the Village Residential Community in contingent on the information provided to the City Council demonstrating that the residents were offered to trim their trees one more time following the passage of the ordinance in 2014. #### CITY COUNCIL/SUCCESSOR AGENCY REPORTS

*Councilmember Argumedo reported that he attended Cinco de Mayo celebration. Councilmember Argumedo congratulated his daughter on graduating University of Arizona with bachelor's degree.* 

Councilmember Mendoza reported that he attended Cinco de Mayo celebration, preschool graduation, and talked about seniors in the Rosewood apartments and their concerns with the increasing rent costs.

It has been stated that Senior Rent Subsidy program was approved and will be launched shortly. City Administrator Cisneros stated that the increases are in compliance with the rent control moratorium, and it helped with keeping the increases low. Councilmember Argumedo asked that the pamphlets are sent out to all effected and provide them with options and also have pamphlet being in English and Spanish.

Councilmember Soria reported that he attended Cinco de Mayo celebration, Club 21 program that supports down syndrome, preschool graduation, and attended Bandini library event.

Mayor Rebollo attended Club 21 event and spoke about special needs training that some City staff is required to take and how beneficial it is for the community and special needs kids. Mayor Rebollo reported that she attended Scholarships for Scholars in Montebello, 25th annual Art Competition Awards for Lucille Royal Ballard, and thanked staff for taking issues on Hempworth in Bandini area. There will be Neighborhood Watch meeting scheduled shortly on that street. Mayor Rebollo announced a Business Watch meeting at Washington and Atlantic. Mayor Rebollo wished everyone a Happy Mother's Day.
