REGULAR MEETING OF MEASURE AA ADVISORY COMMITTEE COMMUNITY SERVICES CONFERENCE ROOM

CALL TO ORDER

Vice Chair Rodriguez called meeting to order at 6:12 p.m. in the Community Services Conference Room.

SCHEDULED MATTERS

1. Approval of the Meeting Minutes of Tuesday, June 12, 2018, held at 6:00 p.m.

Committee Member Reno moved, seconded by Committee Member Basic, to approve meeting minutes of Tuesday, June 12, 2018. The motion carried by the following vote:

Ayes: 4- Vice Chairperson Rodriguez, Committee Members Basic, Grajeda, and Reno. Absent: 1- Committee Member Stinett.

2. Financial Report and Update of Measure AA Recommended/Approved Projects.

Maryam Babaki, Director of Public Works and Development Services, provided a brief overview of the financial update.

3. Allocate \$11, 000 for costs associated with the installation of NO OVERNIGHT PARKING signs along various streets throughout the City.

Seung Yang, Deputy Director of Engineering, provided an overview of the staff report. Discussion ensued.

Committee Member Grajeda requested clarification on attachment 2. She asked if the term "large vehicles" includes recreational vehicles. Ms. Babaki clarified the term large vehicles includes recreational vehicles, but it also includes trucks, tractor trails, etc., specifically affecting the industrial areas. Committee Member Basic requested to know when the no overnight parking signs will be installed. Mr. Yang said that he communicated with LA County and requested to get the ball rolling right away due to the urgency and safety nature of the project. Mr. Yang estimates its implementation within the next two weeks. Committee Member Basic asked if Community Services and the Sheriff would enforce the no overnight parking signs. Ms. Babaki said that, with the installation of these signs, that Community Services and the Sheriff can enforce the no overnight parking signs.

Committee Member Grajeda moved, seconded by Committee Member Basic, to approve the allocation of \$11,000 for costs associated with the installation of NO OVERNIGHT PARKING signs along various streets throughout the City. The motion carried by the following vote:
